

California Manufacturing Facts

Manufacturers in California account for 10.85 percent of the total output in the state, employing 8.02 percent of the workforce. Total output from manufacturing was \$239.01 billion in 2013. In addition, there were 1,254,300 manufacturing employees in California in 2014, with an average annual compensation of \$90,538 in 2013.

Figure 1: California Manufacturing Output, in Billions of Dollars, 2000–2013

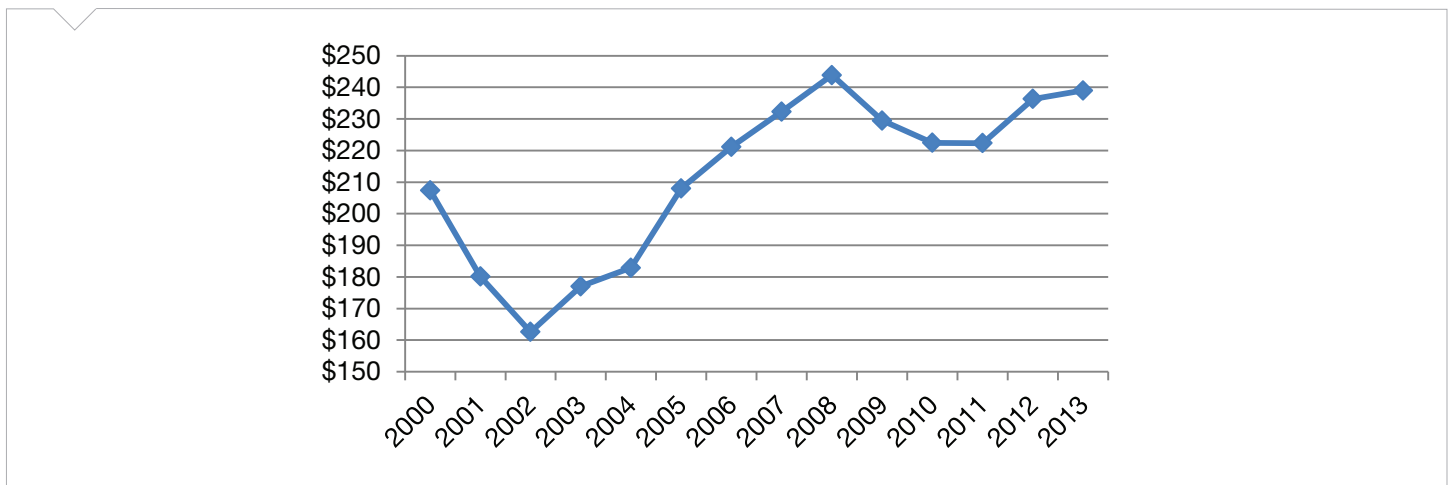
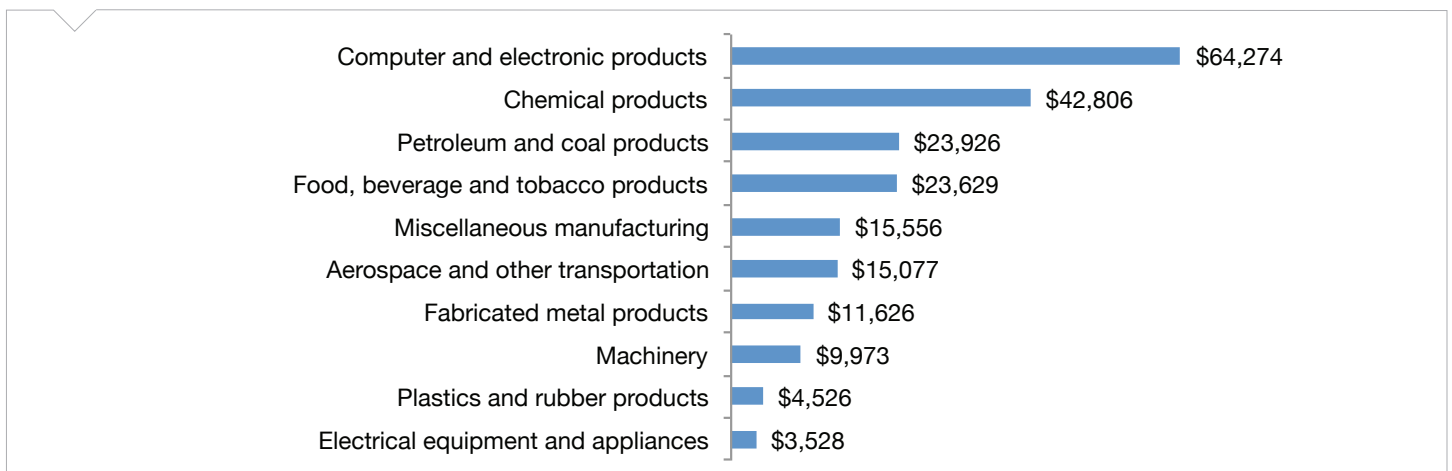


Figure 2: Top 10 California Manufacturing Sectors, in Millions of Dollars, 2012



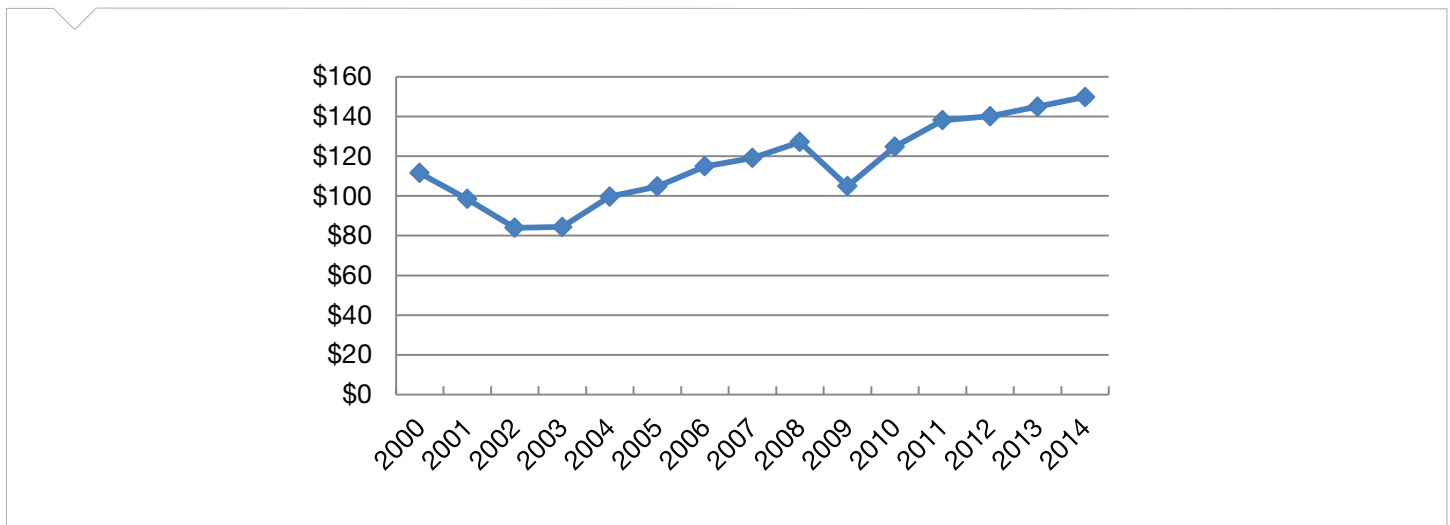
California Export Facts

Manufacturers help to drive California's economy, with \$149.79 billion in manufactured goods exports in 2014. That same year, \$63.14 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 25.20 percent of its employment stemmed from exports in 2011. Small businesses comprised 95.90 percent of all exporters in California.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
