

Delaware Manufacturing Facts

Manufacturers in Delaware account for 7.25 percent of the total output in the state, employing 5.67 percent of the workforce. Total output from manufacturing was \$4.55 billion in 2013. In addition, there were 25,200 manufacturing employees in Delaware in 2014, with an average annual compensation of \$69,571 in 2013.

Figure 1: Delaware Manufacturing Output, in Billions of Dollars, 2000–2013

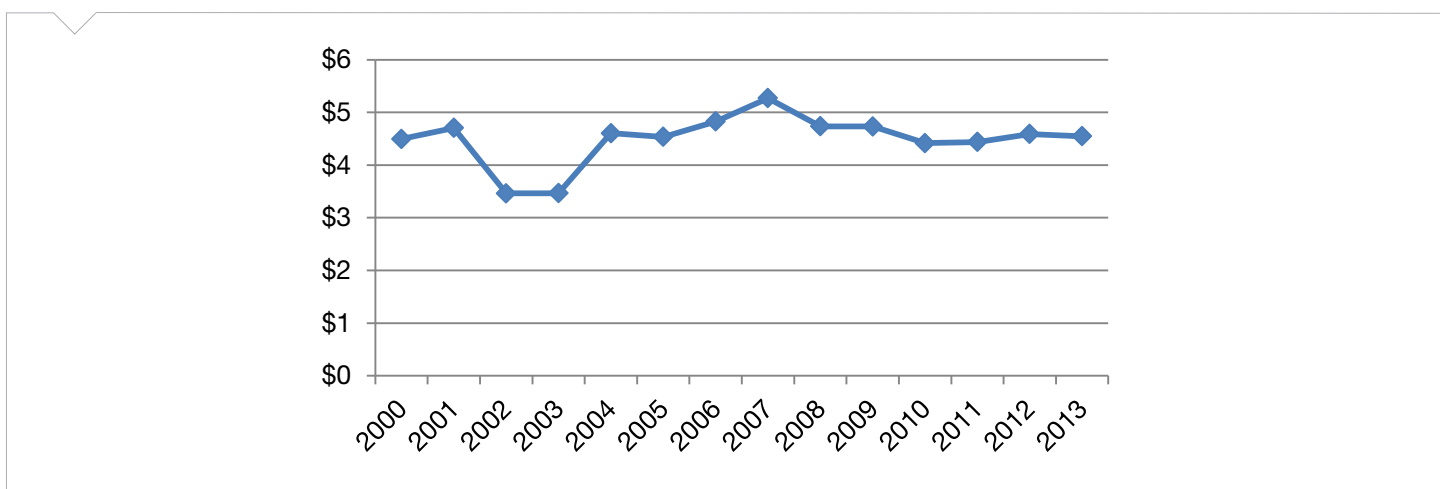
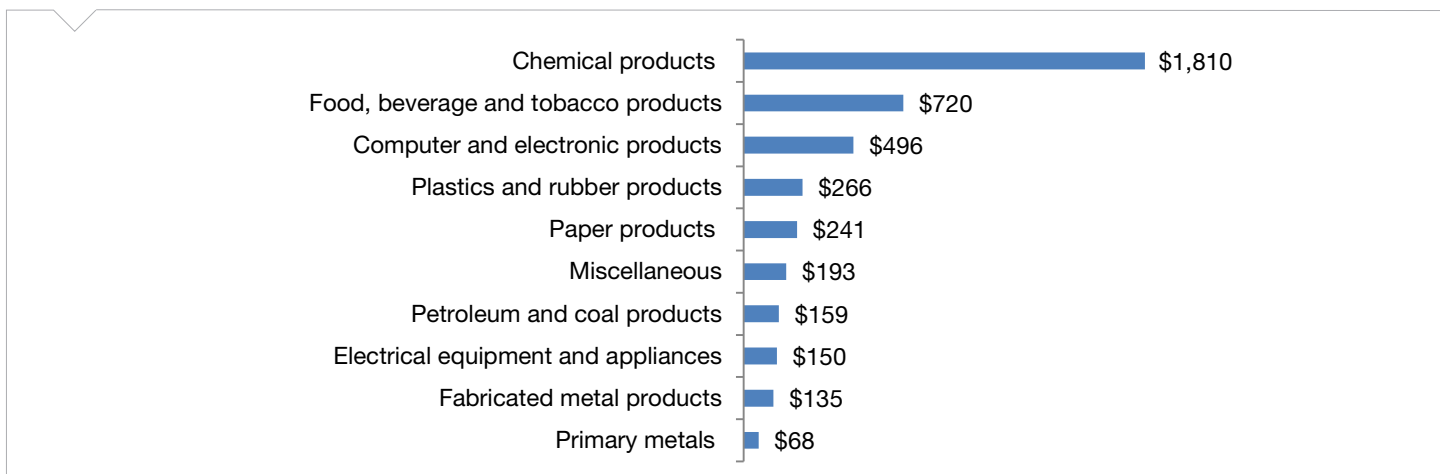


Figure 2: Top 10 Delaware Manufacturing Sectors, in Millions of Dollars, 2012



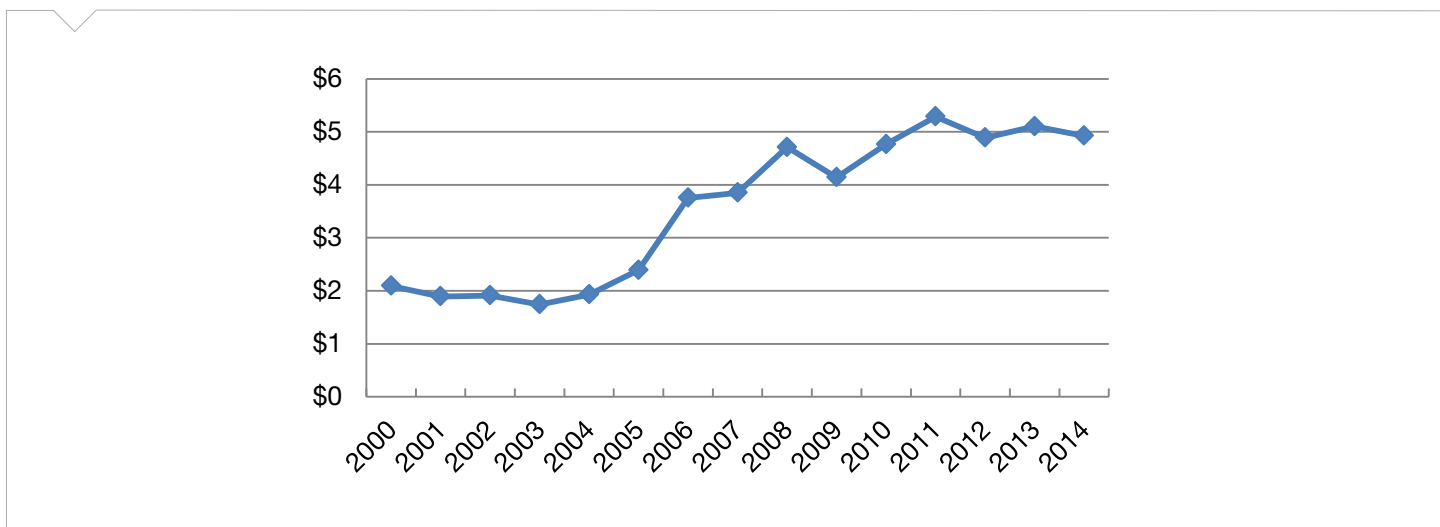
Delaware Export Facts

Manufacturers help to drive Delaware's economy, with \$4.93 billion in manufactured goods exports in 2014. That same year, \$1.03 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 21.00 percent of its employment stemmed from exports in 2011. Small businesses comprised 86.70 percent of all exporters in Delaware.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
