## **Hawaii** Manufacturing Facts

Manufacturers in Hawaii account for 1.79 percent of the total output in the state, employing 2.10 percent of the workforce. Total output from manufacturing was \$1.35 billion in 2013. In addition, there were 13,300 manufacturing employees in Hawaii in 2014, with an average annual compensation of \$42,238 in 2013.

Figure 1: Hawaii Manufacturing Output, in Millions of Dollars, 2000–2013





Figure 2: Top 10 Hawaii Manufacturing Sectors, in Millions of Dollars, 2012




## **Hawaii** Export Facts

Manufacturers help to drive Hawaii's economy, with \$1.24 billion in manufactured goods exports in 2014. That same year, \$0.87 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 4.70 percent of its employment stemmed from exports in 2011. Small businesses comprised 85.80 percent of all exporters in Hawaii.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
