

# Idaho Manufacturing Facts

Manufacturers in Idaho account for 12.25 percent of the total output in the state, employing 9.12 percent of the workforce. Total output from manufacturing was \$7.62 billion in 2013. In addition, there were 59,100 manufacturing employees in Idaho in 2014, with an average annual compensation of \$61,515 in 2013.

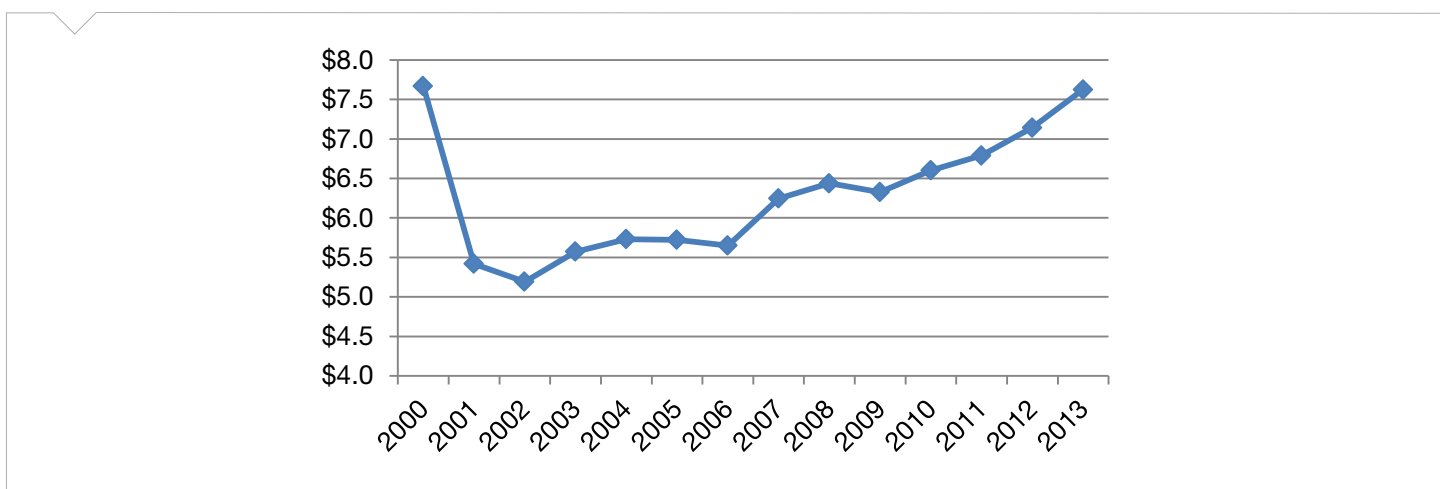

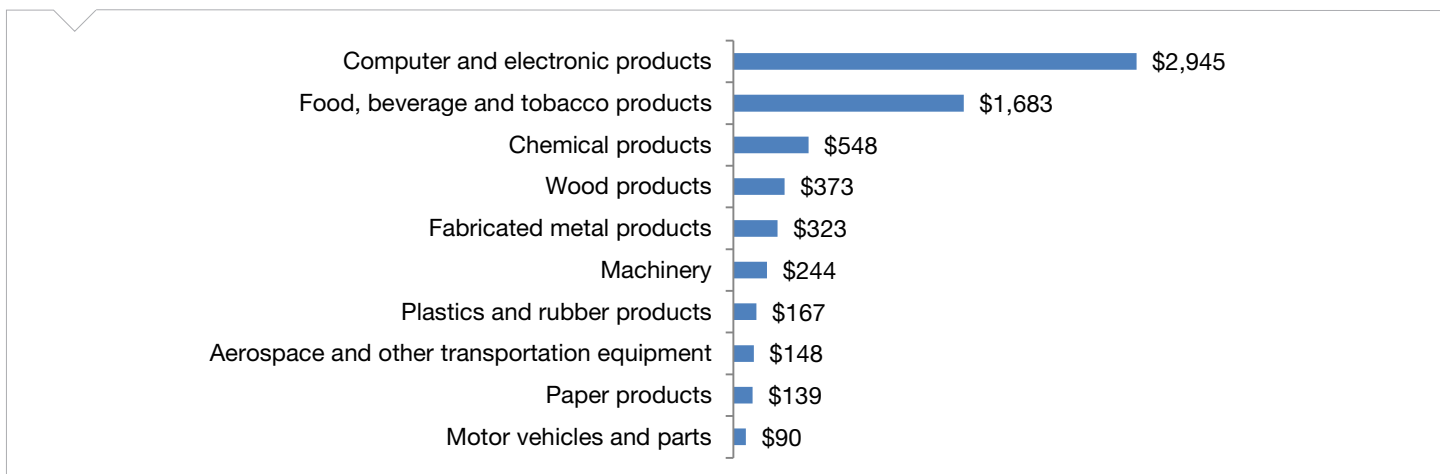

**Figure 2:** Top 10 Idaho Manufacturing Sectors, in Millions of Dollars, 2012



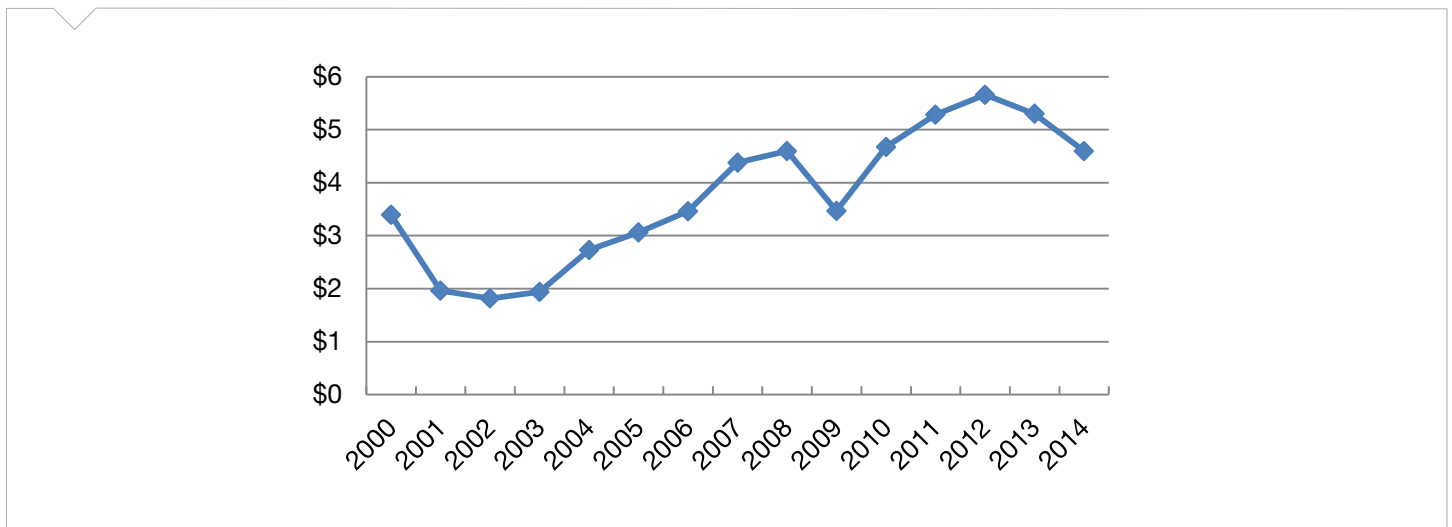
# Idaho Export Facts

Manufacturers help to drive Idaho's economy, with \$4.60 billion in manufactured goods exports in 2014. That same year, \$2.45 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 18.00 percent of its employment stemmed from exports in 2011. Small businesses comprised 83.30 percent of all exporters in Idaho.

## Additional Trade Facts

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
