

Illinois Manufacturing Facts

Manufacturers in Illinois account for 14.05 percent of the total output in the state, employing 9.86 percent of the workforce. Total output from manufacturing was \$101.28 billion in 2013. In addition, there were 579,600 manufacturing employees in Illinois in 2014, with an average annual compensation of \$78,971 in 2013.

Figure 1: Illinois Manufacturing Output, in Billions of Dollars, 2000–2013

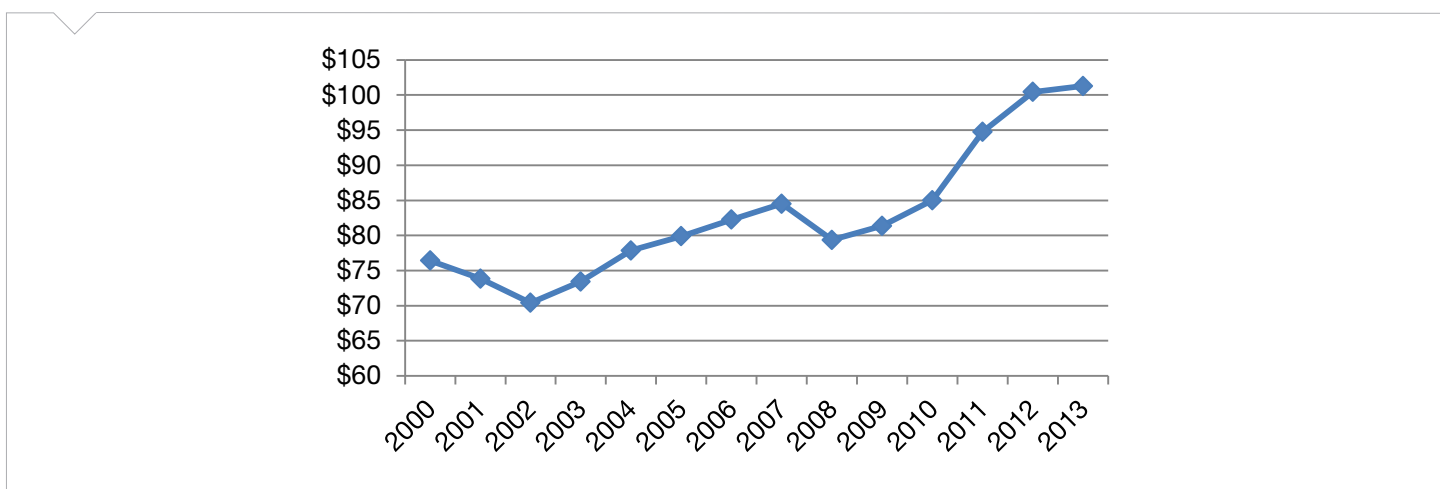
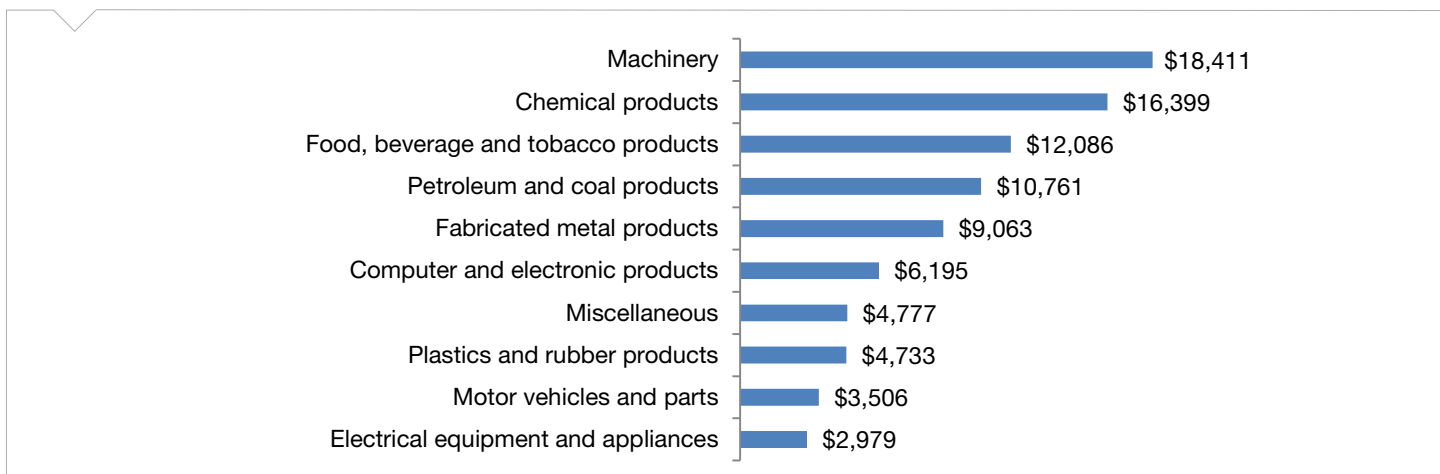


Figure 2: Top 10 Illinois Manufacturing Sectors, in Millions of Dollars, 2012



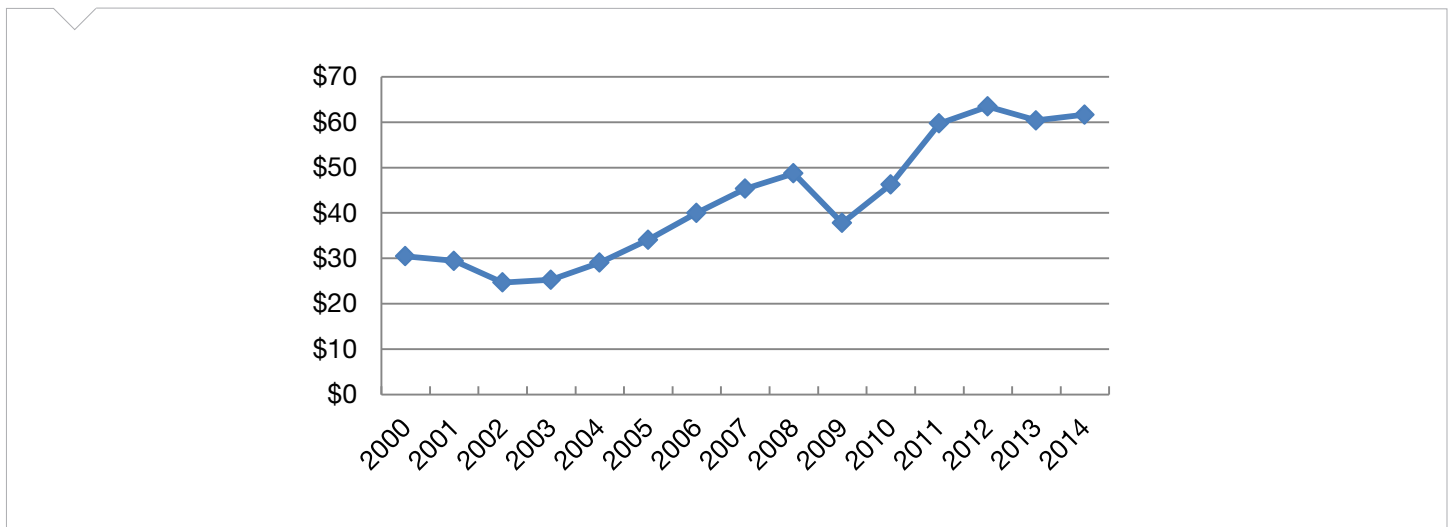
Illinois Export Facts

Manufacturers help to drive Illinois's economy, with \$61.64 billion in manufactured goods exports in 2014. That same year, \$34.96 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 26.90 percent of its employment stemmed from exports in 2011. Small businesses comprised 90.00 percent of all exporters in Illinois.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
