

Indiana Manufacturing Facts

Manufacturers in Indiana account for 30.06 percent of the total output in the state, employing 17.30 percent of the workforce. Total output from manufacturing was \$95.31 billion in 2013. In addition, there were 523,200 manufacturing employees in Indiana in 2014, with an average annual compensation of \$70,333 in 2013.

Figure 1: Indiana Manufacturing Output, in Billions of Dollars, 2000–2013

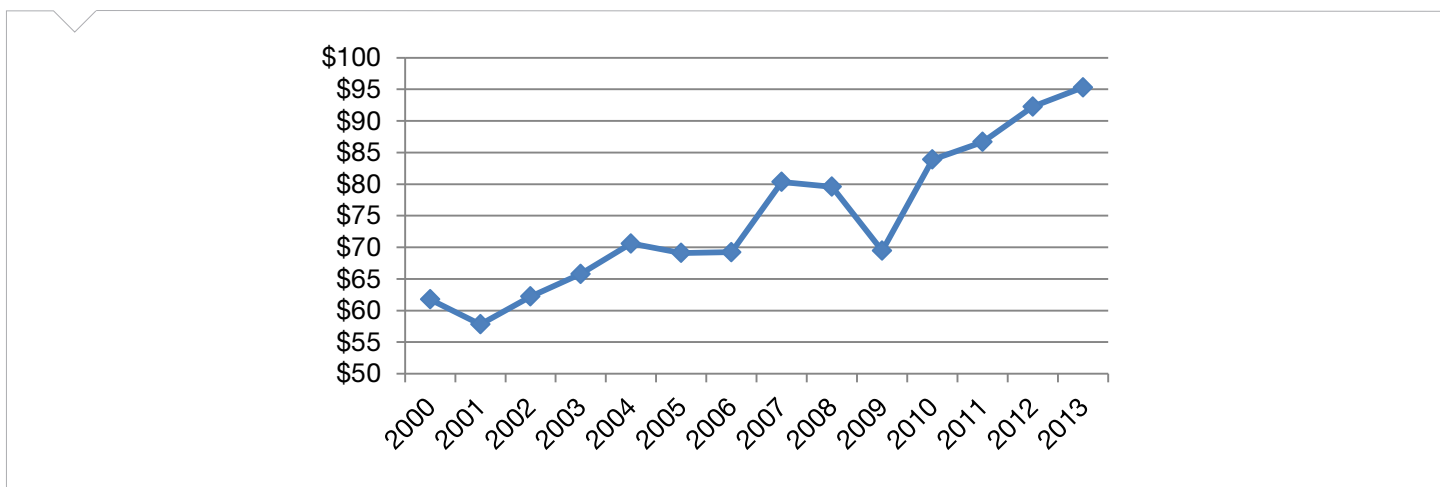
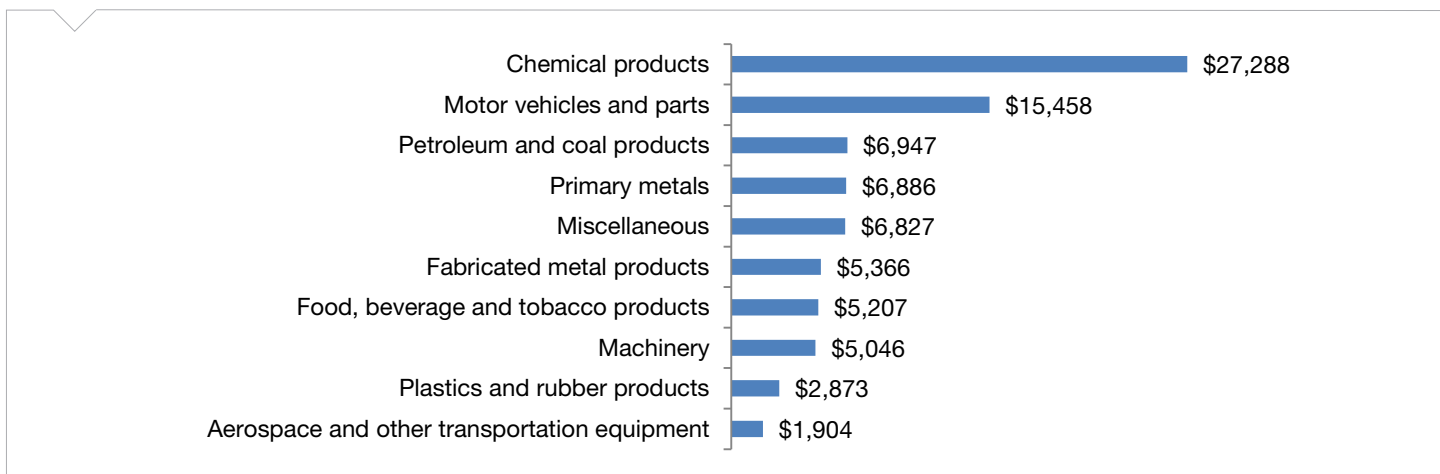


Figure 2: Top 10 Indiana Manufacturing Sectors, in Millions of Dollars, 2012



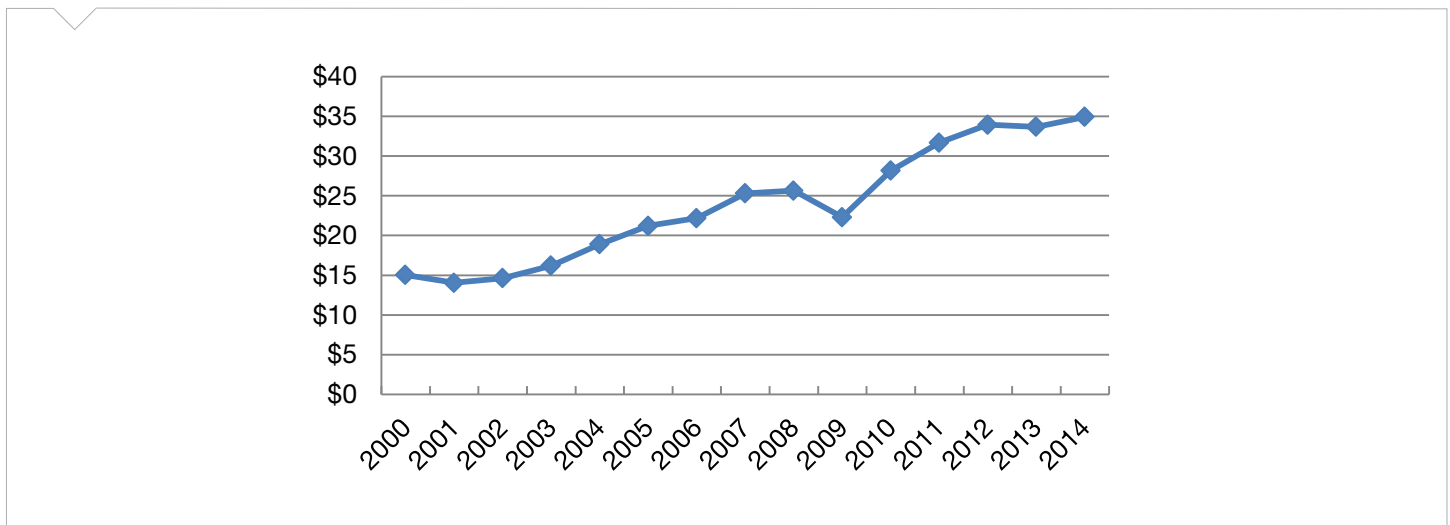
Indiana Export Facts

Manufacturers help to drive Indiana's economy, with \$34.93 billion in manufactured goods exports in 2014. That same year, \$19.52 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 24.70 percent of its employment stemmed from exports in 2011. Small businesses comprised 84.90 percent of all exporters in Indiana.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
