## **Montana** Manufacturing Facts

Manufacturers in Montana account for 6.65 percent of the total output in the state, employing 4.22 percent of the workforce. Total output from manufacturing was \$2.93 billion in 2013. In addition, there were 19,300 manufacturing employees in Montana in 2014, with an average annual compensation of \$46,841 in 2013.

Figure 1: Montana Manufacturing Output, in Billions of Dollars, 2000–2013





Figure 2: Top 10 Montana Manufacturing Sectors, in Millions of Dollars, 2012




## **Montana** Export Facts

Manufacturers help to drive Montana's economy, with \$1.01 billion in manufactured goods exports in 2014. That same year, \$0.64 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 23.50 percent of its employment stemmed from exports in 2011. Small businesses comprised 85.00 percent of all exporters in Montana.
