Arizona Manufacturing Facts

Manufacturers in Arizona account for 8.10 percent of the total output in the state, employing 5.9 percent of the workforce. Total output from manufacturing was \$23.53 billion in 2015. In addition, there were 159,100 manufacturing employees in Arizona in 2016, with an average annual compensation of \$81,886 in 2015.

Figure 1: Arizona Manufacturing Output, in Billions of Dollars, 2005–2015





Figure 2: Top 10 Arizona Manufacturing Sectors, in Millions of Dollars, 2014



Arizona Export Facts

Manufacturers help to drive Arizona's economy, with \$18.46 billion in manufactured goods exports in 2016. That same year, \$10.11 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 27.40 percent of its employment stemmed from exports in 2011. Small businesses comprised 88.0 percent of all exporters in Arizona.
