

Kentucky Manufacturing Facts

Manufacturers in Kentucky account for 19.40 percent of the total output in the state, employing 12.8 percent of the workforce. Total output from manufacturing was \$37.77 billion in 2015. In addition, there were 243,600 manufacturing employees in Kentucky in 2016, with an average annual compensation of \$68,728 in 2015.

Figure 1: Kentucky Manufacturing Output, in Billions of Dollars, 2005–2015

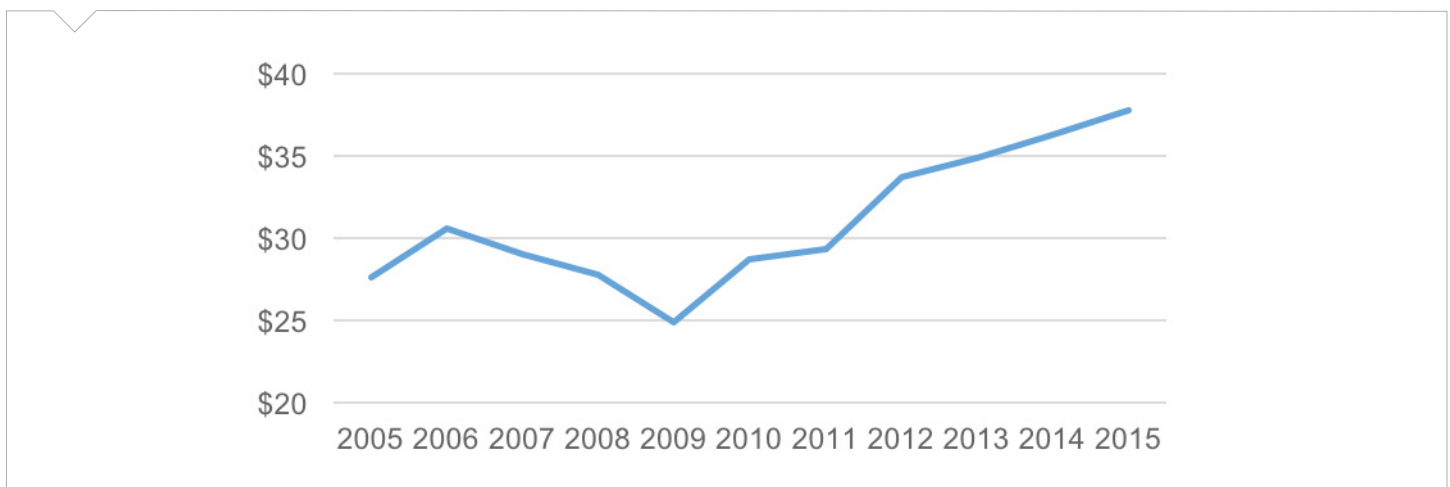
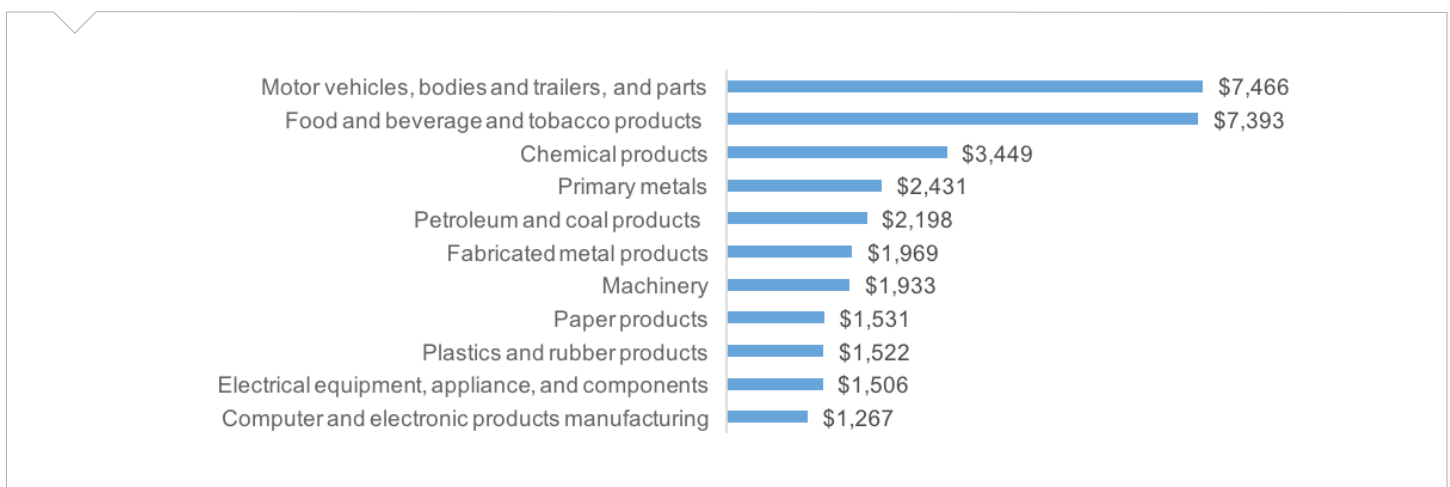


Figure 2: Top 10 Kentucky Manufacturing Sectors, in Millions of Dollars, 2014



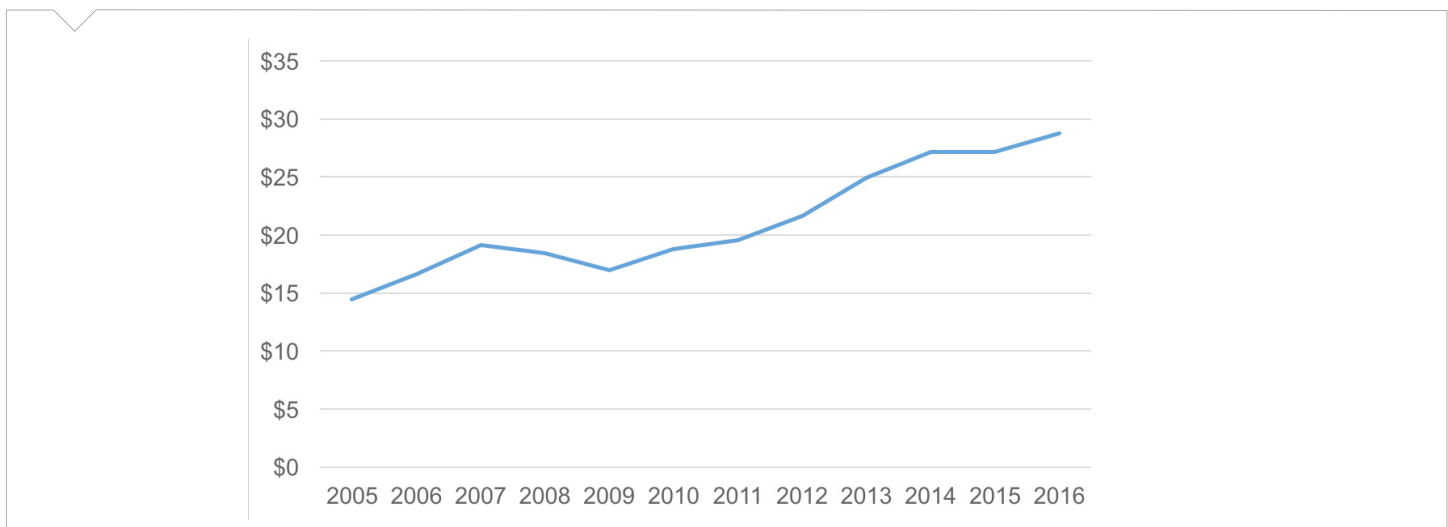
Kentucky Export Facts

Manufacturers help to drive Kentucky's economy, with \$28.74 billion in manufactured goods exports in 2016. That same year, \$11.66 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 23.50 percent of its employment stemmed from exports in 2011. Small businesses comprised 79.0 percent of all exporters in Kentucky.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Columbia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
