

# Mississippi Manufacturing Facts

Manufacturers in Mississippi account for 16.82 percent of the total output in the state, employing 12.5 percent of the workforce. Total output from manufacturing was \$15.71 billion in 2015. In addition, there were 143,100 manufacturing employees in Mississippi in 2016, with an average annual compensation of \$58,085 in 2015.

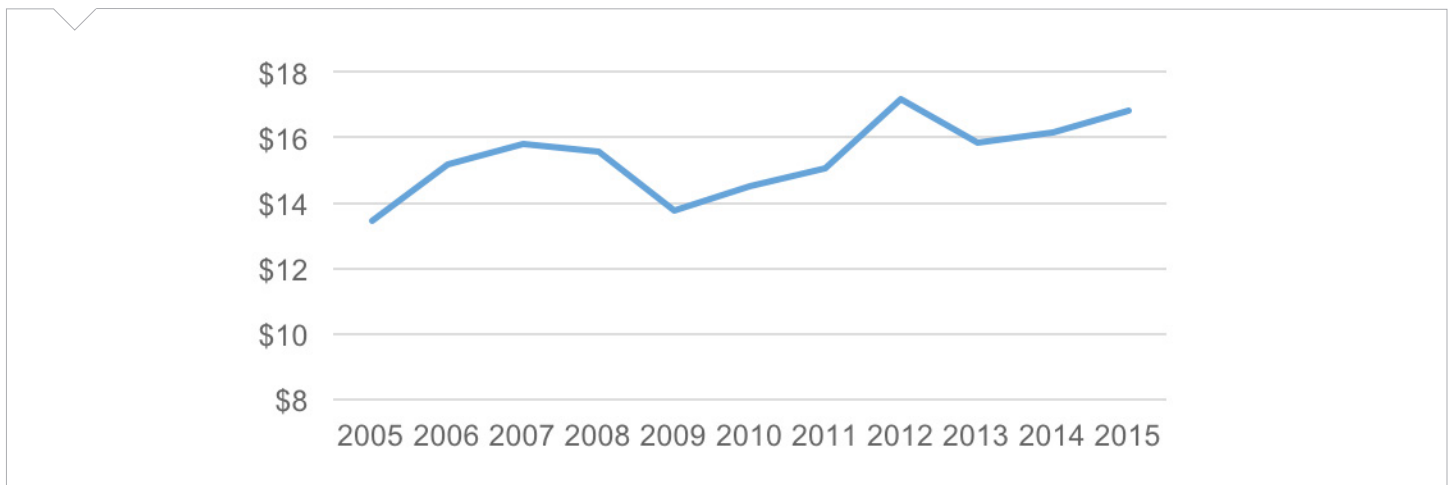

**Figure 2:** Top 10 Mississippi Manufacturing Sectors, in Millions of Dollars, 2014



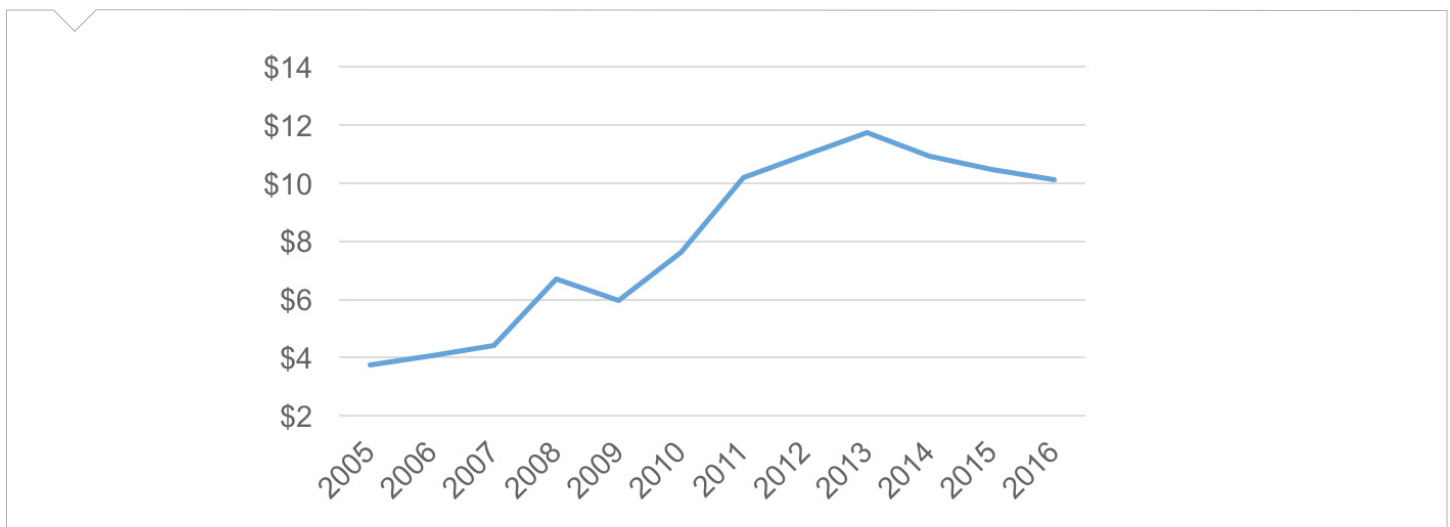
# Mississippi Export Facts

Manufacturers help to drive Mississippi's economy, with \$10.12 billion in manufactured goods exports in 2016. That same year, \$5.98 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 13.60 percent of its employment stemmed from exports in 2011. Small businesses comprised 77.0 percent of all exporters in Mississippi.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
