

Rhode Island Manufacturing Facts

Manufacturers in Rhode Island account for 8.01 percent of the total output in the state, employing 8.5 percent of the workforce. Total output from manufacturing was \$4.57 billion in 2015. In addition, there were 41,600 manufacturing employees in Rhode Island in 2016, with an average annual compensation of \$69,796 in 2015.

Figure 1: Rhode Island Manufacturing Output, in Billions of Dollars, 2005–2015

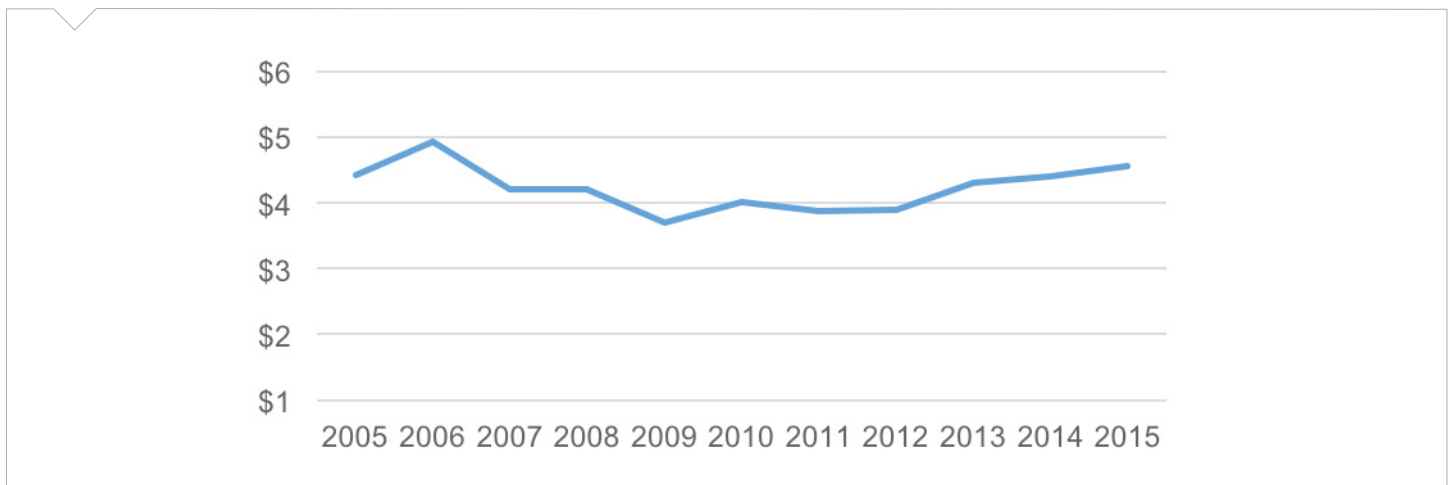
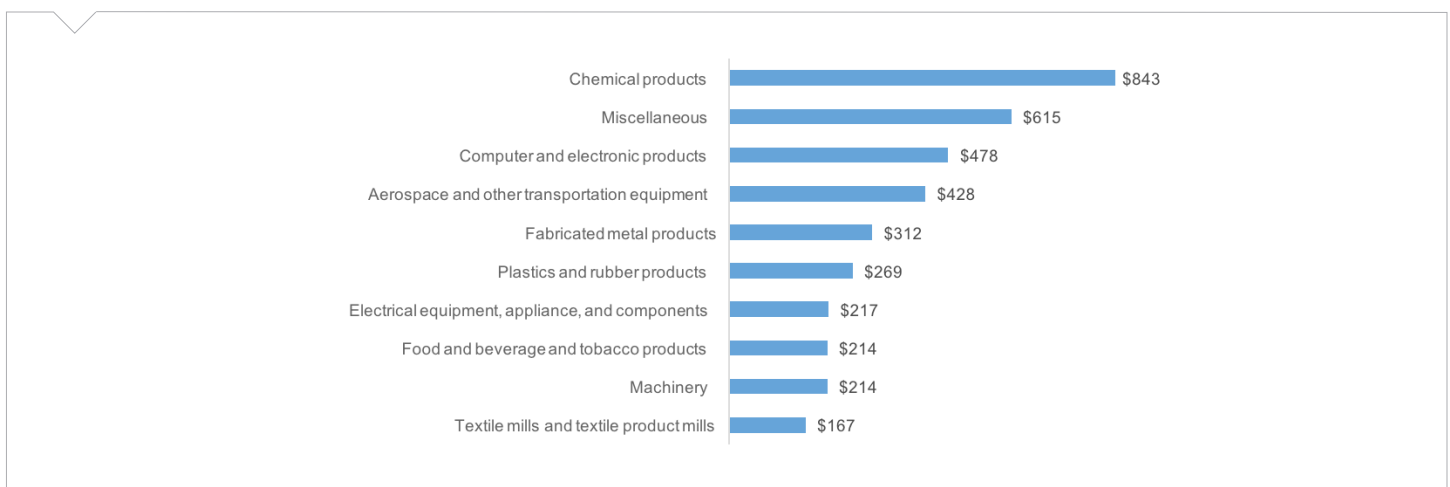


Figure 2: Top 10 Rhode Island Manufacturing Sectors, in Millions of Dollars, 2014



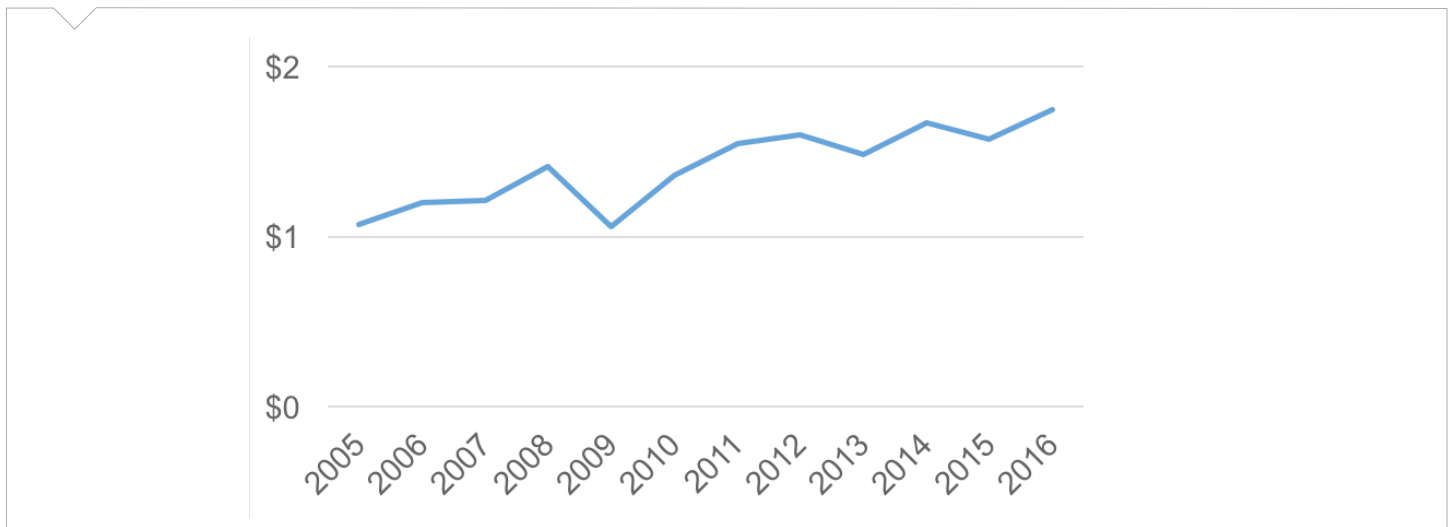
Rhode Island Export Facts

Manufacturers help to drive Rhode Island's economy, with \$1.75 billion in manufactured goods exports in 2016. That same year, \$0.86 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 16.90 percent of its employment stemmed from exports in 2011. Small businesses comprised 88.0 percent of all exporters in Rhode Island.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Columbia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
