

South Carolina Manufacturing Facts

Manufacturers in South Carolina account for 16.83 percent of the total output in the state, employing 11.7 percent of the workforce. Total output from manufacturing was \$33.44 billion in 2015. In addition, there were 239,500 manufacturing employees in South Carolina in 2016, with an average annual compensation of \$70,229 in 2015.

Figure 1: South Carolina Manufacturing Output, in Billions of Dollars, 2005–2015

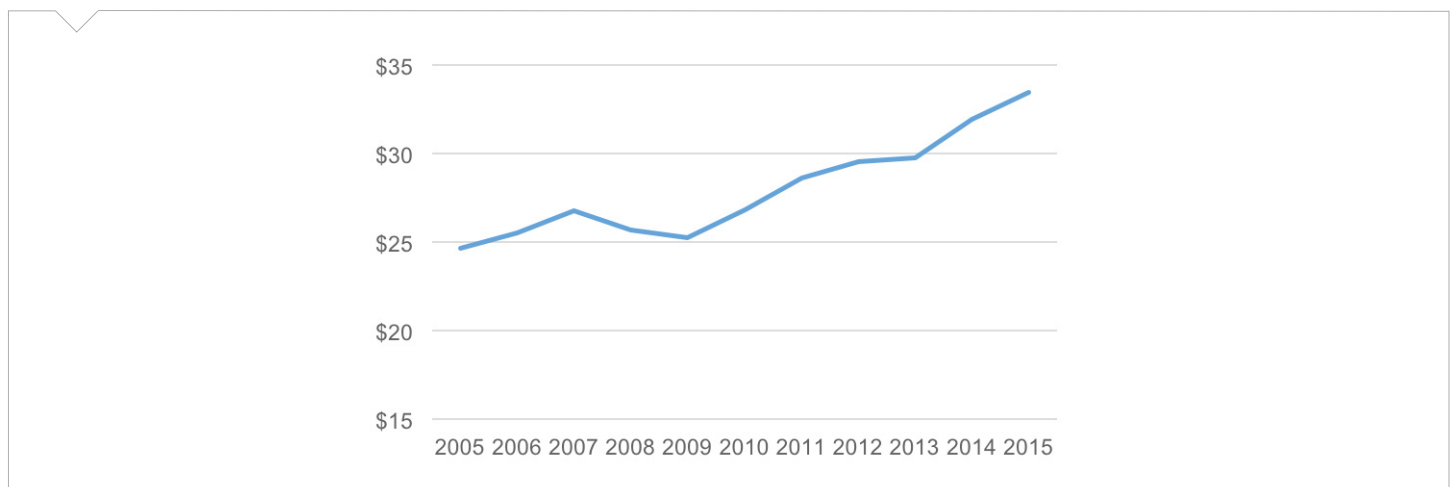
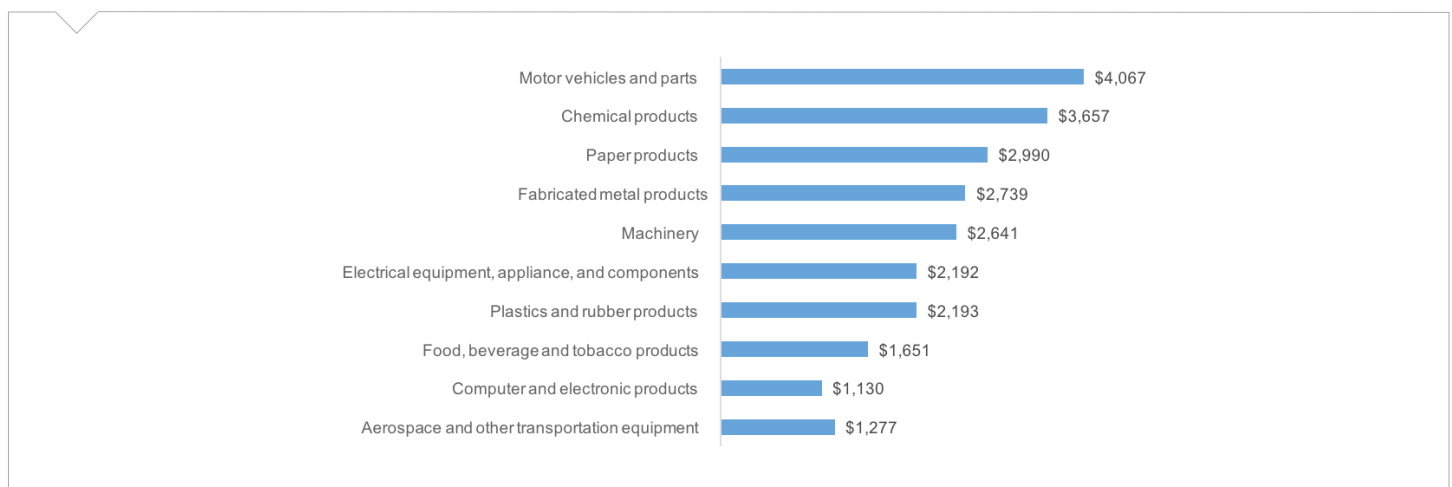


Figure 2: Top 10 South Carolina Manufacturing Sectors, in Millions of Dollars, 2014



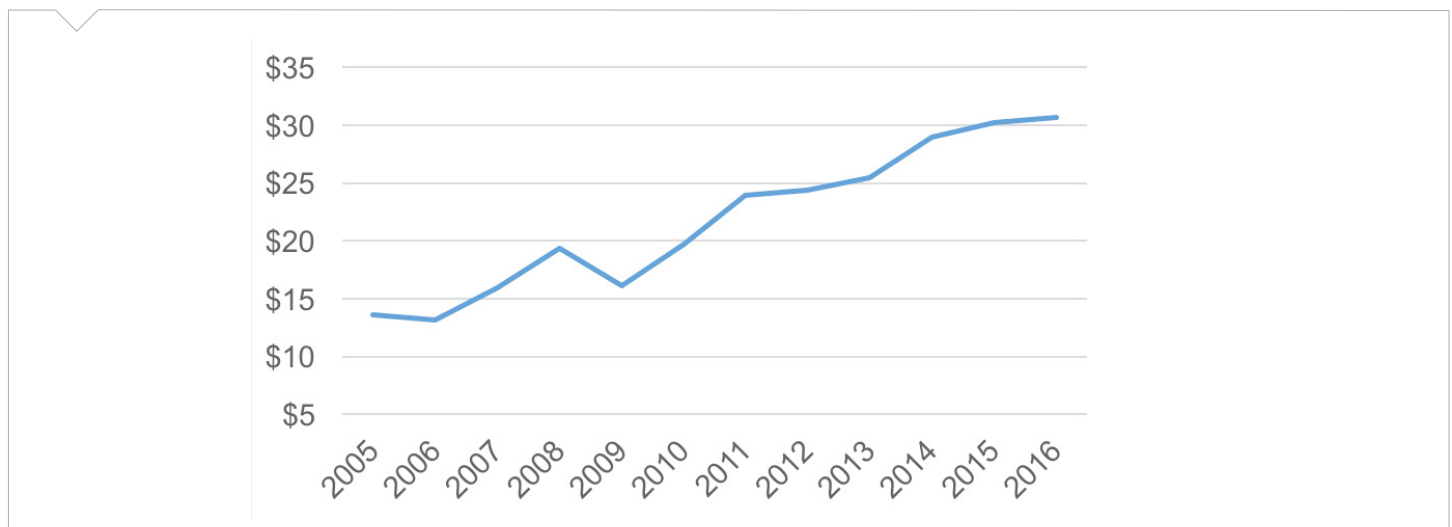
South Carolina Export Facts

Manufacturers help to drive South Carolina's economy, with \$30.70 billion in manufactured goods exports in 2016. That same year, \$9.08 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 29.90 percent of its employment stemmed from exports in 2011. Small businesses comprised 85.0 percent of all exporters in South Carolina.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
