## **Rhode Island Manufacturing Facts**

Manufacturers in Rhode Island account for 7.96 percent of the total output in the state, employing 8.62 percent of the workforce. Total output from manufacturing was \$4.37 billion in 2014. In addition, there were 41,700 manufacturing employees in Rhode Island in 2015, with an average annual compensation of \$67,501 in 2013.

Figure 1: Rhode Island Manufacturing Output, in Billions of Dollars, 2000–2014





Figure 2: Top 10 Rhode Island Manufacturing Sectors, in Millions of Dollars, 2013




## **Rhode Island Export Facts**

Manufacturers help to drive Rhode Island's economy, with \$1.68 billion in manufactured goods exports in 2014. That same year, \$0.74 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 16.90% percent of its employment stemmed from exports in 2011. Small businesses comprised 88.7 percent of all exporters in Rhode Island.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
