

# Hawaii Manufacturing Facts

Manufacturers in Hawaii account for 2.1 percent of the total output in the state, employing 2.1 percent of the workforce. Total output from manufacturing was \$1.87 billion in 2017. In addition, there were 13.8 manufacturing employees in Hawaii in 2017, with an average annual compensation of \$46,148 in 2016.

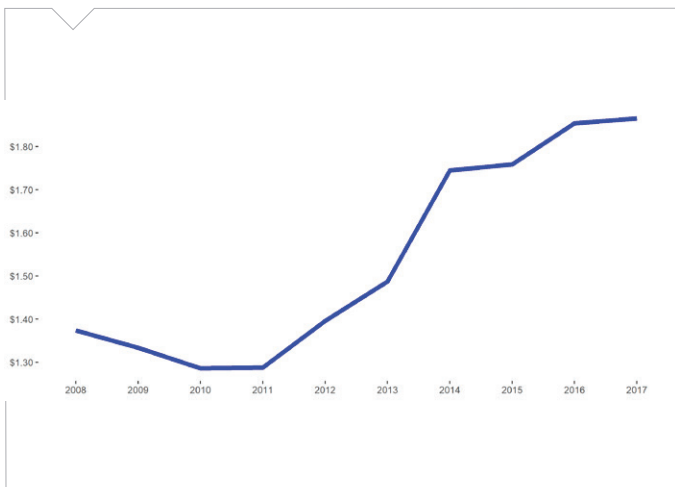

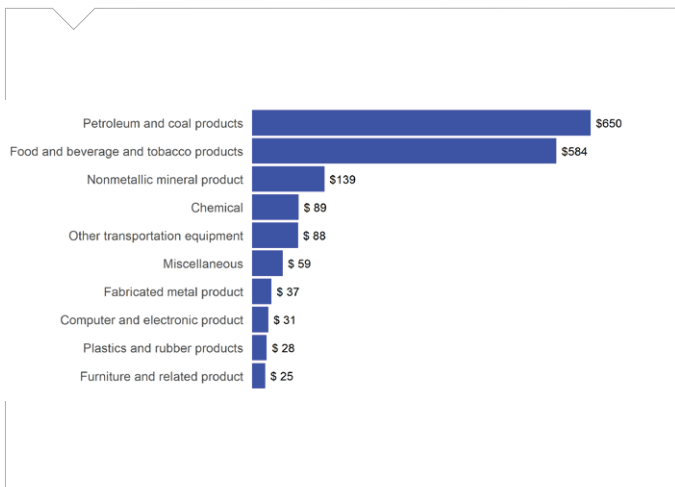

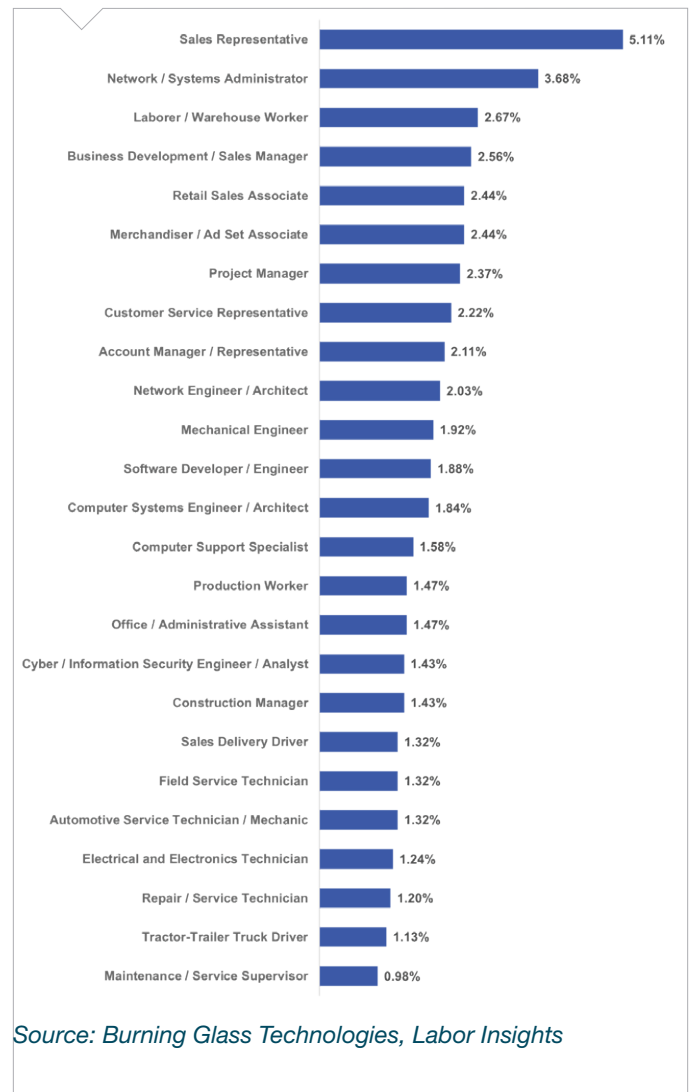
**Figure 1:** Hawaii Manufacturing Output, in Billions of Dollars, 2005–2017

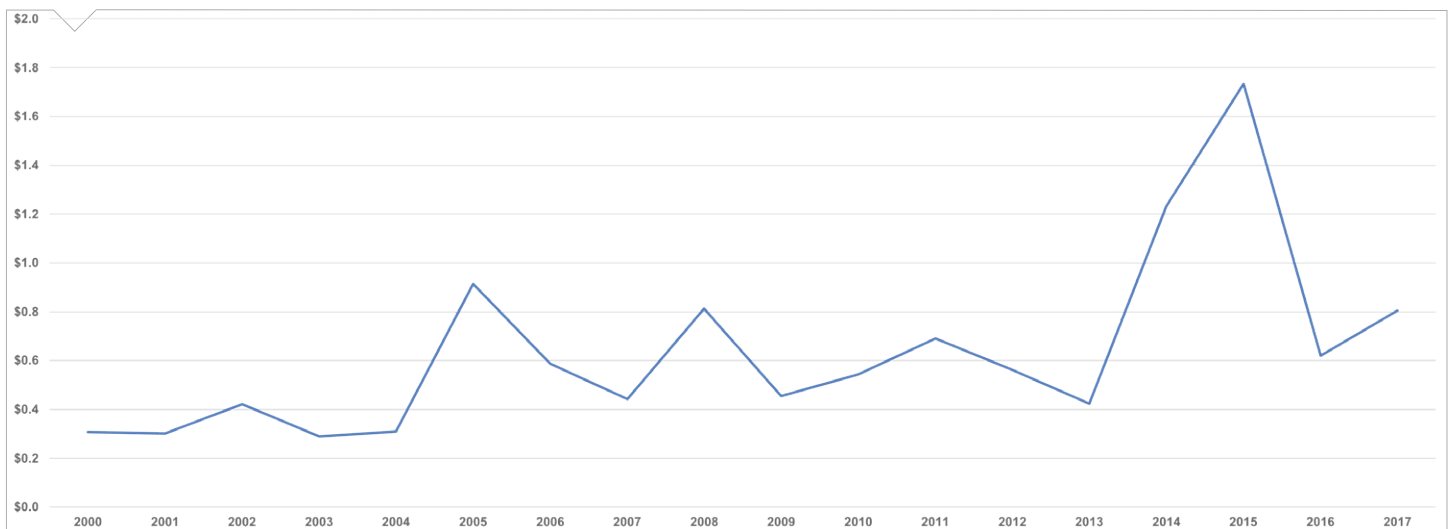
# Hawaii Export Facts

Manufacturers help to drive Hawaii's economy, with \$0.80 billion in manufactured goods exports in 2017. That same year, \$0.59 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 4.7 percent of its employment stemmed from exports in 2011. Small businesses comprised 87 percent of all exporters in Hawaii.

## Additional Trade Facts

- The 20 U.S. FTA partners purchased nearly 48 percent (\$637.5 billion) of U.S. manufactured goods exports in 2017 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Colombia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
