

New Hampshire Manufacturing Facts

Manufacturers in New Hampshire account for 10.9 percent of the total output in the state, employing 9.9 percent of the workforce. Total output from manufacturing was \$8.49 billion in 2016. In addition, there were 66,300 manufacturing employees in New Hampshire in 2016, with an average annual compensation of \$78,104 in 2016.

Figure 1: New Hampshire Manufacturing Output, in Billions of Dollars, 2005–2016

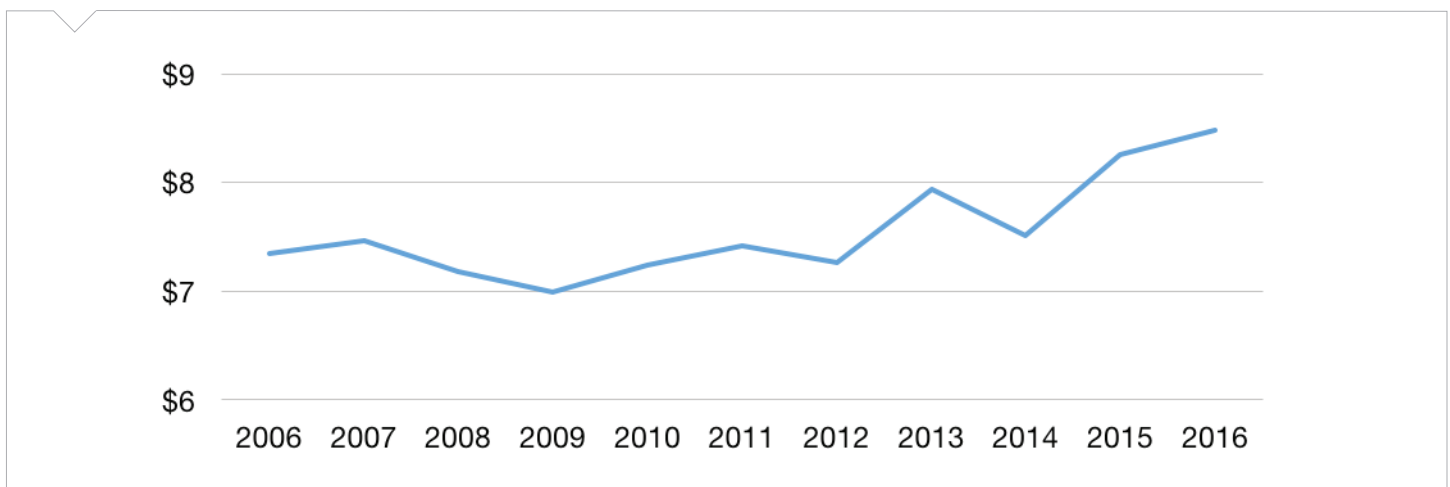
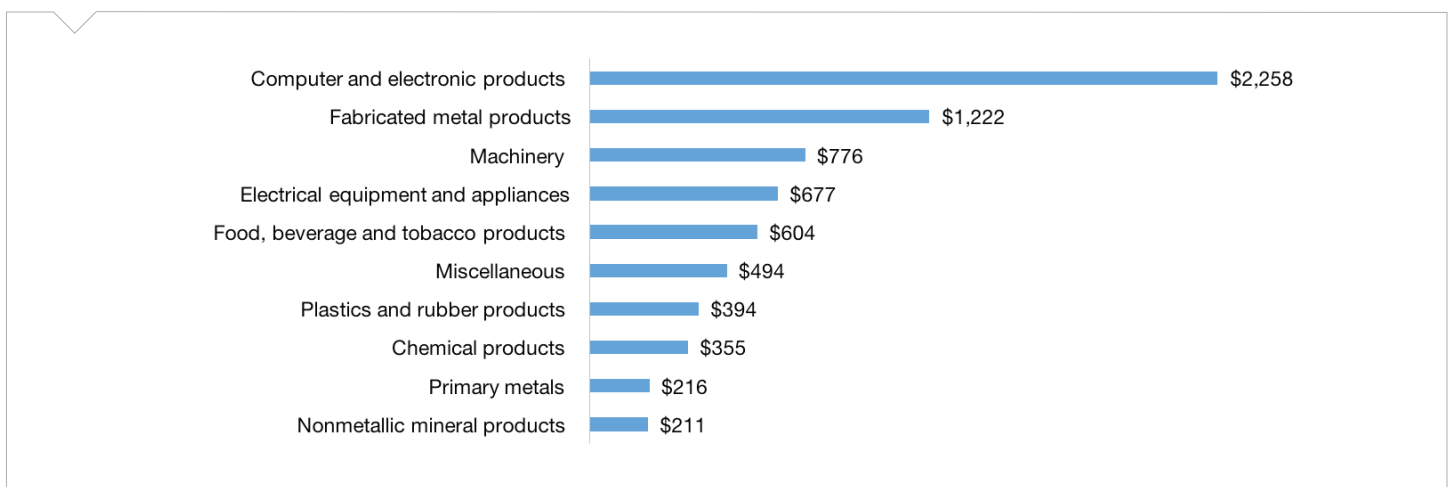


Figure 2: Top 10 New Hampshire Manufacturing Sectors, in Millions of Dollars, 2015



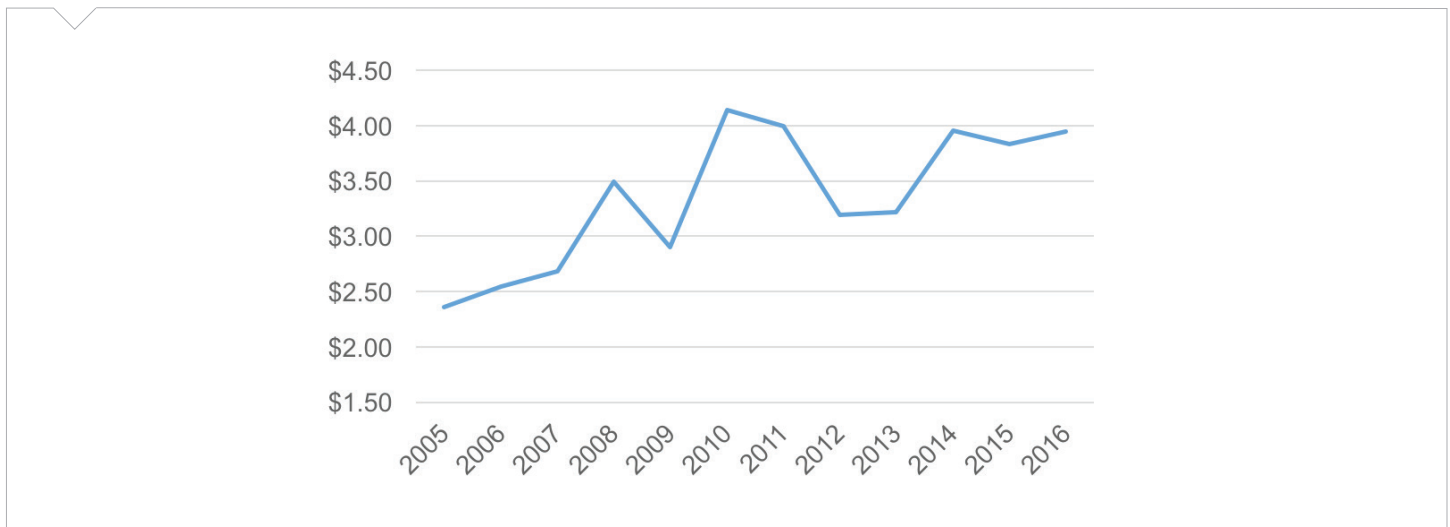
New Hampshire Export Facts

Manufacturers help to drive New Hampshire's economy, with \$3.95 billion in manufactured goods exports in 2016. That same year, \$1.39 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 25.7 percent of its employment stemmed from exports in 2011. Small businesses comprised 87 percent of all exporters in New Hampshire.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Columbia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
