

North Dakota Manufacturing Facts

Manufacturers in North Dakota account for 7.1 percent of the total output in the state, employing 5.6 percent of the workforce. Total output from manufacturing was \$3.71 billion in 2016. In addition, there were 24,500 manufacturing employees in North Dakota in 2016, with an average annual compensation of \$60,959 in 2016.

Figure 1: North Dakota Manufacturing Output, in Billions of Dollars, 2005–2016

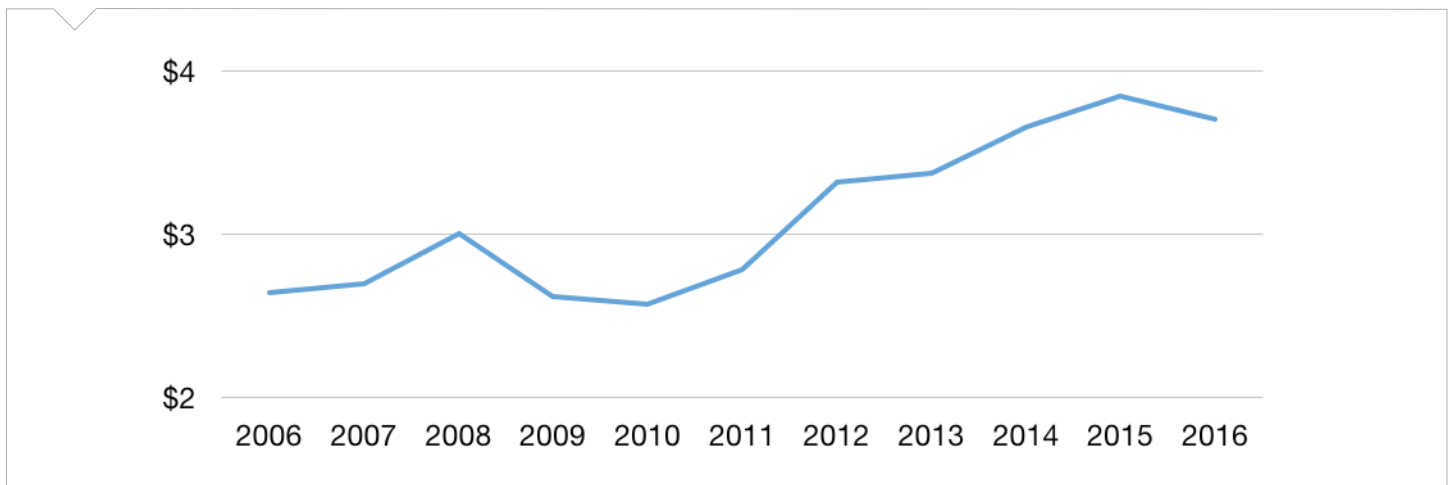
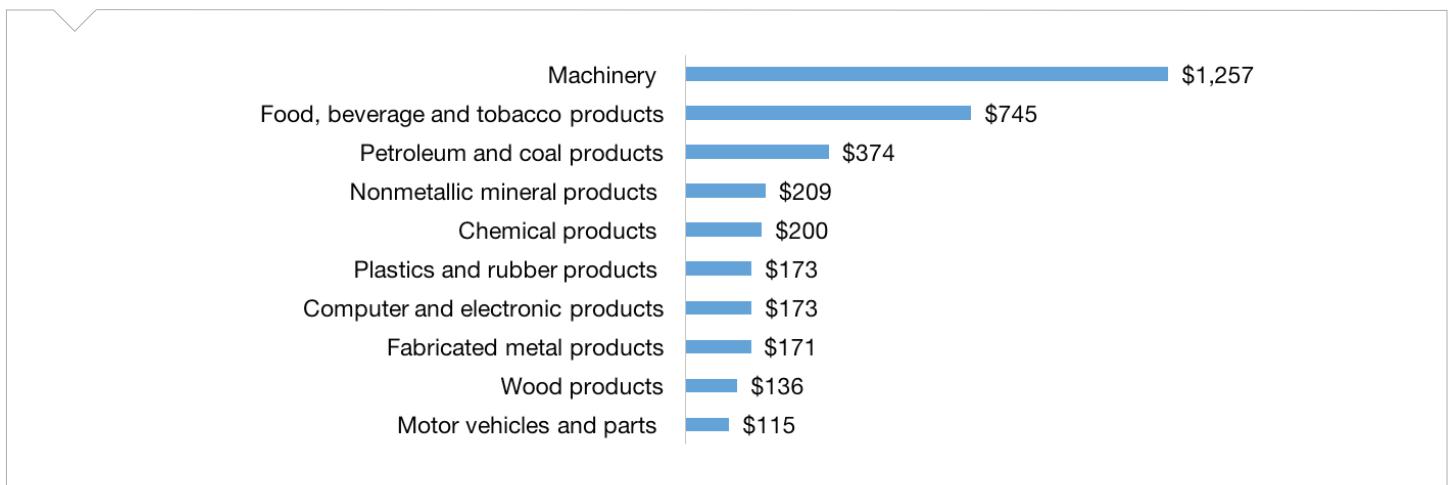


Figure 2: Top 10 North Dakota Manufacturing Sectors, in Millions of Dollars, 2015



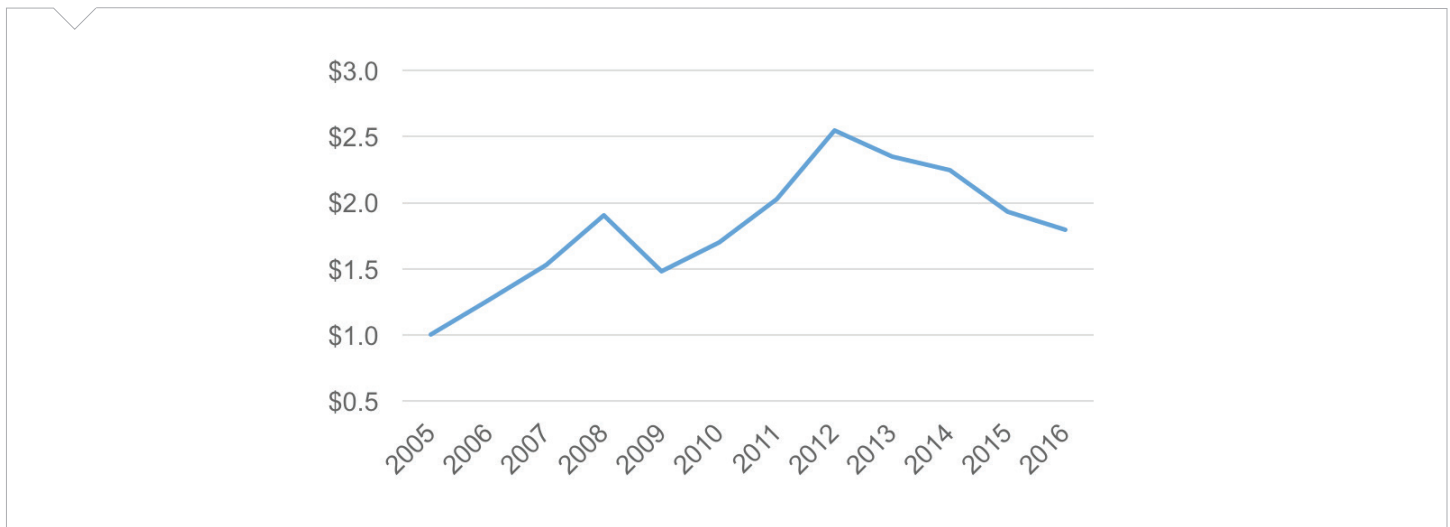
North Dakota Export Facts

Manufacturers help to drive North Dakota's economy, with \$1.80 billion in manufactured goods exports in 2016. That same year, \$1.48 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 13.9 percent of its employment stemmed from exports in 2011. Small businesses comprised 82 percent of all exporters in North Dakota.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
