

# Virginia Manufacturing Facts

Manufacturers in Virginia account for 8.5 percent of the total output in the state, employing 5.9 percent of the workforce. Total output from manufacturing was \$42.12 billion in 2016. In addition, there were 229,800 manufacturing employees in Virginia in 2016, with an average annual compensation of \$68,907 in 2016.

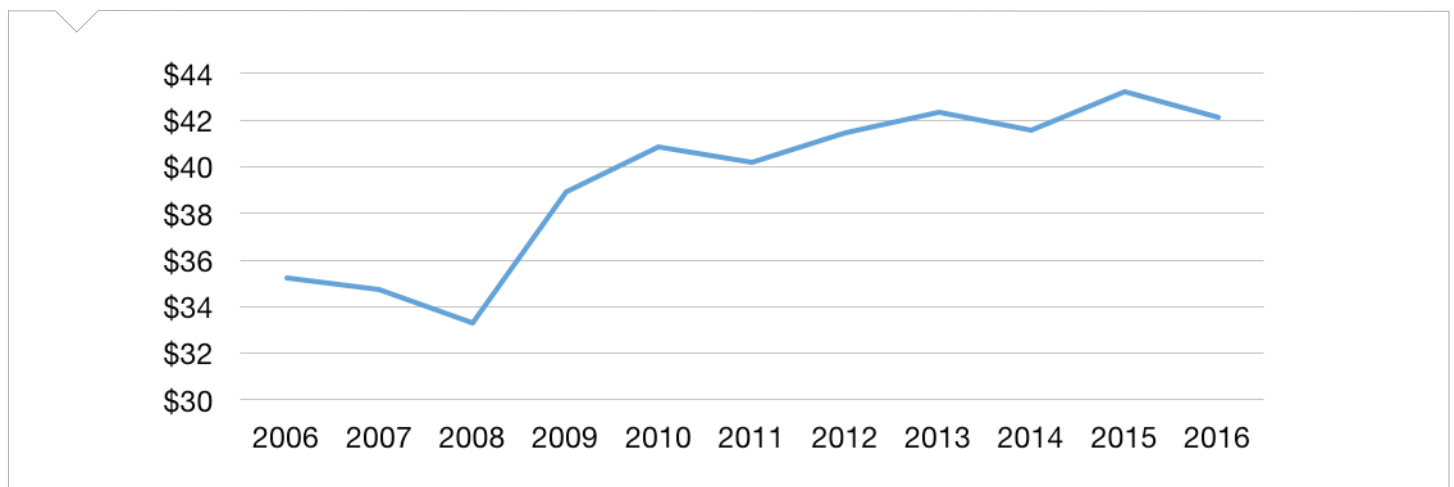

**Figure 2:** Top 10 Virginia Manufacturing Sectors, in Millions of Dollars, 2015



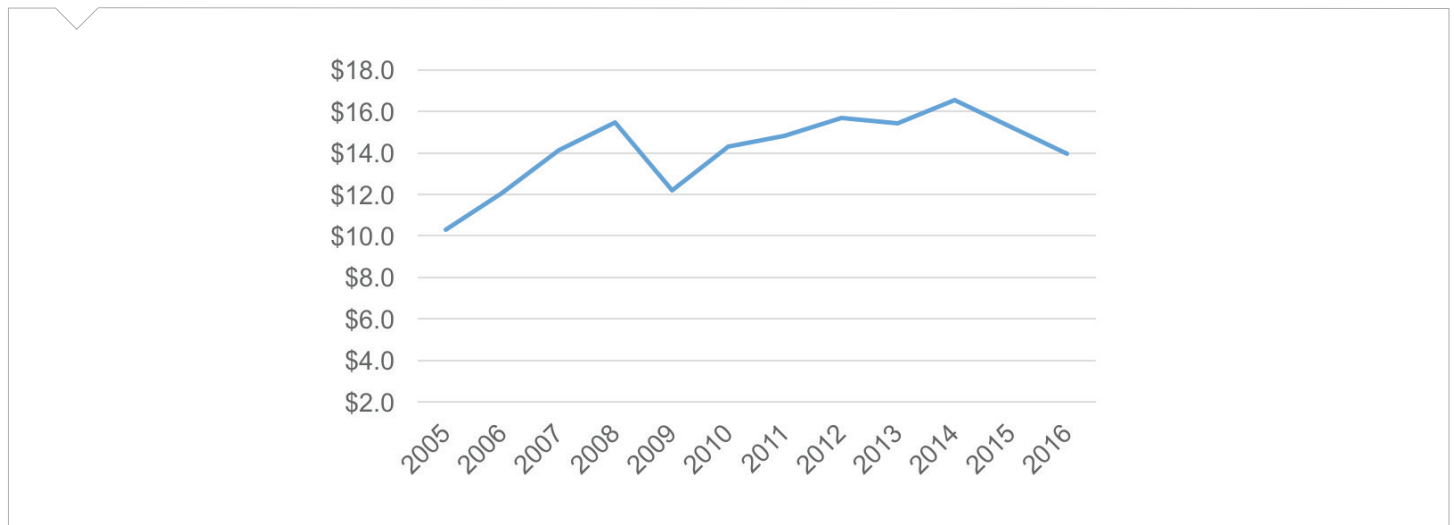
# Virginia Export Facts

Manufacturers help to drive Virginia's economy, with \$13.94 billion in manufactured goods exports in 2016. That same year, \$5.41 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 20.3 percent of its employment stemmed from exports in 2011. Small businesses comprised 86 percent of all exporters in Virginia.

## Additional Trade Facts

- The 20 U.S. FTA partners purchased nearly 48 percent (\$603 billion) of U.S. manufactured goods exports in 2016 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Columbia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
