The NAM Award for Manufacturing Legislative Excellence

The National Association of Manufacturers (NAM) formally recognizes members of Congress who consistently supported the manufacturing community during the 111th Congress (2009–2010). U.S. senators and representatives maintaining a 70 percent or better voting record on designated Key Manufacturing Votes are winners of the *NAM Award for Manufacturing Legislative Excellence*.

Each vote was selected by executives from small, medium and large manufacturing firms serving on the NAM's Key Vote Advisory Committee (KVAC). Working in close coordination with NAM staff, the KVAC used the following guidelines in selecting votes:

- Votes must be on issues on which the NAM took clear positions and either: a) expressed this position in communications to Congress prior to the vote; or b) communicated its position to Congress with regularity in the recent past.
- Votes must be recorded floor votes. Voice votes, committee/subcommittee votes and conference committee votes will not be considered.
- Votes should be substantive. Procedural votes should be used only in cases where they are a true measure of support or opposition to the bill.
- Votes may be on final passage or on key amendments.

The NAM is non-partisan, does not have a political action committee and does not endorse candidates. The NAM aggressively seeks to influence the terms of public policy debates, to reward members of Congress who have supported our agenda and to inform those who have been on the wrong side of the issues that manufacturers and workers in America expect better from our elected officials.

We encourage NAM members to publicly thank winners of the *NAM Award for Manufacturing Legislative Excellence* (recognized in this publication in boldface) for their support of pro-growth, pro-manufacturing policies.

House Votes

111th Congress

1) Unlimited Damage Awards Against Employers. Vote on H.R. 12, the Paycheck Fairness Act, which would expose employers to unlimited damage awards and encourage more class action litigation against employers. Approved 256-163 on Jan. 9, 2009 (Roll No. 8). The NAM opposed the bill, noting that factors such as work experience and job location play a key role in compensation and that its passage would likely prompt employers to purchase additional legal liability insurance, thus increasing their costs and decreasing their ability to raise wages, increase benefits or hire new workers. **NAM POSITION: No.**

2) Exposing Employers to Pay Discrimination Claims. Vote on Senate-passed S. 181, the Lilly Ledbetter Fair Pay Act. Approved 250-177 on Jan. 27, 2009 (Roll No. 37) and signed into law (P.L. 111-2) on Jan. 29, 2009. The NAM opposed the bill, which significantly expands employers' exposure to pay discrimination claims under civil rights laws. **NAM POSITION: No.**

3) Economic Stimulus. Vote on the Conference Report to H.R. 1, the American Recovery and Reinvestment Act. Approved 246-183 on Feb. 13, 2009 (Roll No. 70) and signed into law (P.L. 111-5) on Feb. 17, 2009. The NAM supported the legislation, believing that the overall plan, while not perfect, balanced tax cuts and investment and was designed to help working Americans and those who provide their jobs. **NAM POSITION: Yes.**

4) Waxman-Markey Cap-and-Trade Bill. Vote on H.R. 2454, the American Clean Energy and Security Act. Approved 219-212 on June 26, 2009 (Roll No. 477). The NAM opposed the bill, which would regulate and add costs to all manufacturers and permit Congress to pick winners and losers through the distribution of allocations to industries. **NAM POSITION: No.**

5) "Say on Pay"/Executive Compensation. Vote on H.R. 3269, the Corporate and Financial Institution Compensation Fairness Act. Approved 237-185 on July 31, 2009 (Roll No. 686). The NAM opposed provisions in the bill that would: 1) require an annual, non-binding shareholder vote on executive compensation; and 2) grant the government authority over employee compensation for certain companies. **NAM POSITION: No.**

6) Health Care, Part 1: Employer Mandates, Public Option and Surtax on S-Corporations. Vote on H.R. 3962, the Affordable Health Care for America Act. Approved 220-215 on Nov. 7, 2009 (Roll No. 887) but never considered by the Senate. The NAM opposed the bill, which would drive up manufacturers' health care costs. **NAM POSITION: No.**

7) Making High Estate Tax Rates Permanent. Vote on H.R. 4154, the Permanent Estate Tax Relief for Families, Farmers, and Small Businesses Act. Approved 225-200 on Dec. 3, 2009 (Roll No. 929). The NAM supports efforts to repeal or significantly reform the death tax. The NAM opposed H.R. 4154, which would make permanent the high 2009 estate tax rate of 45 percent and the \$3.5 million exemption. **NAM POSITION: No.**

8) End-Users Derivatives Amendment. Vote on the Murphy (D-NY)/McMahon (D-NY)/Kratovil (D-MD) amendment to H.R. 4173, the Wall Street Reform and Consumer Protection Act. Approved 304-124 on Dec. 10, 2009 (Roll No. 956). The NAM supported the amendment, which would provide an exemption from costly new regulations for companies that use over-the-counter (OTC) derivatives to manage risk, e.g., end-users. **NAM POSITION: Yes.**

9) Health Care, Part 2: Patient Protection and Affordable Care Act. Vote on H.R. 3590, the Senate-passed health care bill that was eventually signed into law (P.L. 111-148). Approved 219-212 on March 21, 2010 (Roll No. 165). The NAM opposed provisions in the bill that will drive up manufacturers' health care costs (excise taxes on health plans, Flexible Spending Account limits, repeal of the income exclusion for prescription drug subsidies, new industry-specific fees to pay for health care, etc.). **NAM POSITION: No.**

10) Budget Reconciliation/Health Care. Vote on H.R. 4872, the Health Care and Education Reconciliation Act. Approved 220-211 on March 21, 2010 (Roll No. 167) and signed into law (P.L. 111-152) on March 30, 2010. The NAM opposed the bill, which will raise costs and ultimately destroy jobs via increased taxes and mandates on manufacturers. **NAM POSITION: No.**

11) Home Star Energy Program. Vote on H.R. 5019, the Home Star Energy Retrofit Act. Approved 246-161 on May 6, 2010 (Roll No. 255). The NAM supported the bill, which would spur consumer demand for energy-efficient products and building materials and result in the creation of more good-paying jobs in the manufacturing sector. **NAM POSITION: Yes.**

12) Addressing the Skills Gap, Innovation and MEP. Vote on H.R. 5116, the America COMPETES Reauthorization Act. Approved 262-150 on May 28, 2010 (Roll No. 332). The NAM supported the bill, which would authorize critical funding for key manufacturing priorities, including: basic research and development; the Hollings Manufacturing Extension Partnership (MEP) program; the Advanced Research Projects Administration for Energy (ARPA-E); and key science, technology, engineering and math (STEM) education programs. **NAM POSITION: Yes.**

13) Curbing Companies' First Amendment Rights. Vote on H.R. 5175, the Democracy is Strengthened by Casting Light on Spending in Elections (DISCLOSE) Act. Approved 219-206 on June 25, 2010 (Roll No. 391). The NAM opposed the bill, which would curb the First Amendment rights of many corporations to express their views about key public policies that impact economic growth and job creation. **NAM POSITION: No.**

14) Miscellaneous Tariff Bill. Vote on H.R. 4380, the U.S. Manufacturing Enhancement Act. Approved 378-43 on July 21, 2010 (Roll No. 456) and signed into law (P.L. 111-227) on Aug. 11, 2010. The NAM supported the bill, which suspends U.S. tariffs on foreign inputs not produced in the United States. **NAM POSITION: Yes.**

15) Oil Spill Liability/Moratorium on Offshore Drilling. Vote on H.R. 3534, the Consolidated Land, Energy, and Aquatic Resources Act. Approved 209-193 on July 30, 2010 (Roll No. 513). The NAM opposed the bill, which would remove the current law's liability cap, forcing the vast majority of American companies out of U.S. waters and, by default, retaining the moratorium on offshore drilling. **NAM POSITION: No.**

16) International Tax Increases. Vote on the Senate-passed version of H.R. 1586, the Education Jobs and Medicaid Assistance Act. Approved 247-161 on Aug. 10, 2010 (Roll No. 518) and signed into law (P.L. 111-226) on Aug. 10, 2010. While the NAM took no position on the bill's spending provisions, manufacturers opposed nearly \$10 billion in proposed tax increases on U.S. companies with operations overseas, noting that more than half of all U.S. manufacturing employees work for these companies. **NAM POSITION: No.**

17) Rare Earth Minerals. Vote on H.R. 6160, the Rare Earths and Critical Materials Revitalization Act. Approved 325-98 on Sept. 29, 2010 (Roll No. 555). The NAM supported the bill, which provides loan guarantees to companies wishing to enter rare earth mineral markets and seeks to enhance competition in these markets, keeping the costs of valuable manufacturing inputs relatively stable. **NAM POSITION: Yes.**

18) Skills Certification/AMERICA Works Act. Vote on H.R. 4072, the AMERICA Works Act. Approved 412-10 on Sept. 29, 2010 (Roll No. 556). The NAM supported the legislation, which would direct targeted federal workforce training dollars toward a registry of industry-recognized, nationally-portable credentials, such as the NAM-Endorsed Manufacturing Skills Certification System developed by The Manufacturing Institute. **NAM POSITION: Yes.**

Senate Votes

111th Congress

1) Exposing Employers to Pay Discrimination Claims. Vote on S. 181, the Lilly Ledbetter Fair Pay Act. Approved 61-36 on Jan. 22, 2009 (Roll No. 14) and signed into law (P.L. 111-2) on Jan. 29, 2009. The NAM opposed the bill, which significantly expands employers' exposure to pay discrimination claims under civil rights laws. **NAM POSITION: No.**

2) Economic Stimulus. Vote on the Conference Report to H.R. 1, the American Recovery and Reinvestment Act. Approved 60-38 on Feb. 13, 2009 (Roll No. 64) and signed into law (P.L. 111-5) on Feb. 17, 2009. The NAM supported the legislation, believing that the overall plan, while not perfect, balanced tax cuts and investment and was designed to help working Americans and those who provide their jobs. **NAM POSITION: Yes.**

3) Opposing Unsafe Drug Importation. Vote on the Dorgan (D-ND) drug importation amendment (SA 2793) to the Senate health care bill. Rejected 51-48, 9 votes shy of the 60 needed to advance the amendment, on Dec. 15, 2009 (Roll No. 377). The NAM opposed the amendment because it would: 1) permit the importation of prescription drugs outside the existing safety system established by the Food and Drug Administration; and 2) impose forced sale mandates on contracts between private companies and their customers and suppliers. **NAM POSITION: No.**

4) Health Care. Vote on H.R. 3590, the Patient Protection and Affordable Care Act. Approved 60-39 on Dec. 24, 2009 (Roll No. 396) and signed into law (P.L. 111-148) on March 23, 2010. The NAM opposed provisions in the bill that will drive up manufacturers' health care costs (excise taxes on health plans, Flexible Spending Account limits, repeal of the tax exclusion for prescription drug subsidies, new industry-specific fees to pay for health care, etc.). **NAM POSITION: No.**

5) Budget Reconciliation/Health Care. Vote on H.R. 4872, the Health Care and Education Reconciliation Act. Approved 56-43 on March 25, 2010 (Roll No. 105) and signed into law (P.L. 111-152) on March 30, 2010. The NAM opposed the bill, which will raise costs and ultimately destroy jobs via increased taxes and mandates on manufacturers. **NAM POSITION: No.**

6) End-Users Derivatives Amendment. Vote on the Chambliss (R-GA)/Shelby (R-AL) substitute amendment to financial services bill S. 3217. Rejected 59-39 on May 12, 2010 (Roll No. 144). The NAM supported the amendment, which would have given business end-users continued access to reasonably priced over-the-counter (OTC) derivatives, providing them with greater financial certainty and exempting them from central clearing, bilateral margining and exchange-trading requirements. **NAM POSITION: Yes.**

7) Ensuring Congressional Input on Greenhouse Gas Regulations/EPA Endangerment. Vote on a motion to proceed to S.J. Res. 26, a Murkowski (R-AK) "resolution of disapproval" aimed at preventing the Environmental Protection Agency (EPA) from regulating greenhouse gas emissions under the Clean Air Act without the input of Congress. Rejected 53-47 on June 10, 2010 (Roll No. 184). The NAM supported the resolution, stressing that EPA regulations, with no guidance from Congress, could establish disincentives for the long-term investments needed to grow jobs and expedite economic recovery. **NAM POSITION: Yes.**

8) Curbing Companies' First Amendment Rights Vote on a procedural motion to proceed to debate S. 3628, the Democracy is Strengthened by Casting Light on Spending in Elections (DISCLOSE) Act. Rejected 57-41, 3 votes shy of the 60 required under Senate rules, on July 27, 2010 (Roll No. 220). The NAM opposed the procedural motion and the bill, which would curb the First Amendment rights of many corporations to express their views about key public policies that impact economic growth and job creation. **NAM POSITION: No.**

9) International Tax Increases. Vote on H.R. 1586, the Education Jobs and Medicaid Assistance Act. Approved 61-39 on Aug. 5, 2010 (Roll No. 228) and signed into law (P.L. 111-226) on Aug. 10, 2010. While the NAM took no position on the bill's spending provisions, manufacturers opposed nearly \$10 billion in proposed tax increases on U.S. companies with operations overseas, noting that more than half of all U.S. manufacturing employees work for these companies. **NAM POSITION: No.**

10) Repealing 1099 Form Reporting Requirement. Vote on a procedural motion on the Johanns (R-NE) amendment to small business bill H.R. 5297. Rejected 46-52, 14 votes shy of the 60 required under Senate rules, on Sept. 14, 2010 (Roll No. 231). The NAM supported the amendment, which would repeal language in the 2010 health care law requiring companies to file separate IRS 1099 forms for all purchases of property and services in excess of \$600. **NAM POSITION: Yes.**

11) Tax Increases on Energy Producers/Higher Energy Costs for Manufacturing. Vote on a procedural motion on the Nelson (D-FL) amendment to small business bill H.R. 5297. Rejected 52-46, 8 votes shy of the 60 required under Senate rules, on Sept. 14, 2010 (Roll No. 232). The NAM opposed the amendment, which would call for \$8 billion in taxes on major energy producers to pay the costs of repealing the IRS 1099 form reporting requirement in the 2010 health care law. The NAM noted that raising the price of fuel on U.S. manufacturers, which use about 30 percent of the nation's energy, will stifle the ability of the U.S. business sector to expand and create jobs. **NAM POSITION: No.**

12) Tax Increases on American Companies with Worldwide Operations. Vote on a procedural motion to proceed to debate S. 3816, the Creating American Jobs and Ending Offshoring Act. Rejected 53-45, 7 votes shy of the 60 required under Senate rules, on Sept. 28, 2010 (Roll No. 242). The NAM opposed the procedural motion and the bill, urging Congress not to increase taxes on companies with worldwide operations, which are responsible for more than half of our nation's exports and employ more than half of all U.S. manufacturing workers. **NAM POSITION: No.**

13) Disapproving Health Care Law's Grandfather Rule. Vote on a procedural motion to proceed to S.J. Res. 39, an Enzi (R-WY) "resolution of disapproval" aimed at preventing the Department of Health and Human Services (HHS) from implementing its proposed "Grandfather Rule" under the 2010 Patient Protection and Affordable Care Act. Rejected 59-40 on Sept. 29, 2010 (Roll No. 244). The NAM supported the motion and the resolution, as the rule would increase manufacturers' health care costs and limit their ability to tailor health plans to meet the needs of their workforce. **NAM POSITION: Yes.**
