

Kentucky Manufacturing Facts

Manufacturers in Kentucky account for 18.30 percent of the total output in the state, employing 12.38 percent of the workforce. Total output from manufacturing was \$33.55 billion in 2013. In addition, there were 232,500 manufacturing employees in Kentucky in 2014, with an average annual compensation of \$64,955 in 2013.

Figure 1: Kentucky Manufacturing Output, in Billions of Dollars, 2000–2013

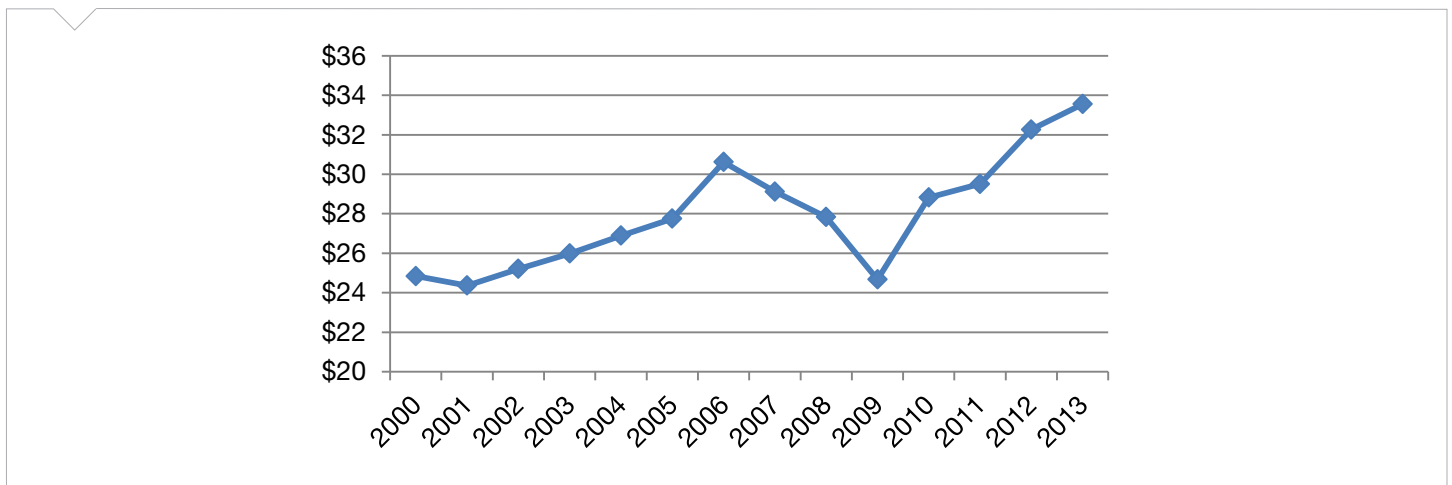
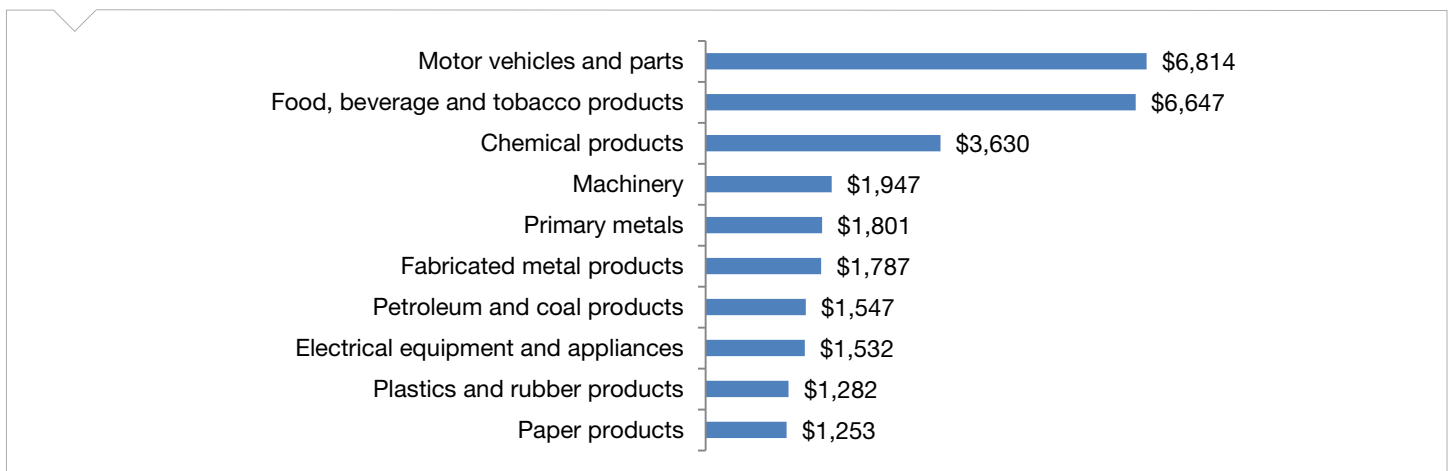


Figure 2: Top 10 Kentucky Manufacturing Sectors, in Millions of Dollars, 2012



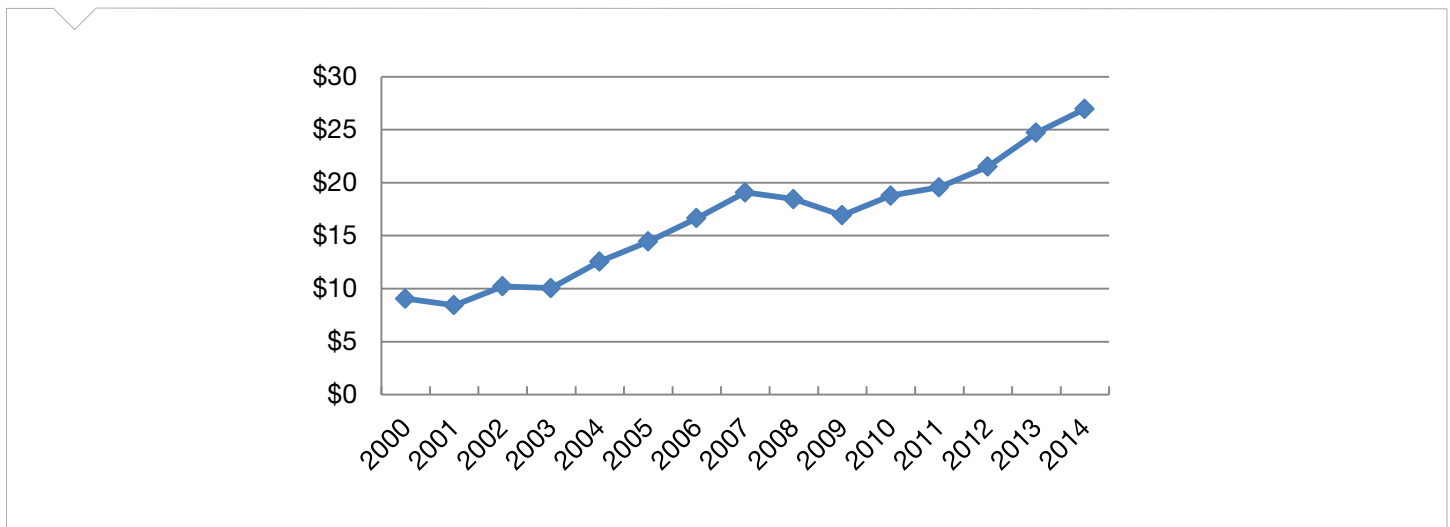
Kentucky Export Facts

Manufacturers help to drive Kentucky's economy, with \$26.97 billion in manufactured goods exports in 2014. That same year, \$11.91 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 23.50 percent of its employment stemmed from exports in 2011. Small businesses comprised 79.50 percent of all exporters in Kentucky.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
