

Vermont Manufacturing Facts

Manufacturers in Vermont account for 10.87 percent of the total output in the state, employing 10.22 percent of the workforce. Total output from manufacturing was \$3.21 billion in 2013. In addition, there were 31,700 manufacturing employees in Vermont in 2014, with an average annual compensation of \$61,384 in 2013.

Figure 1: Vermont Manufacturing Output, in Billions of Dollars, 2000–2013

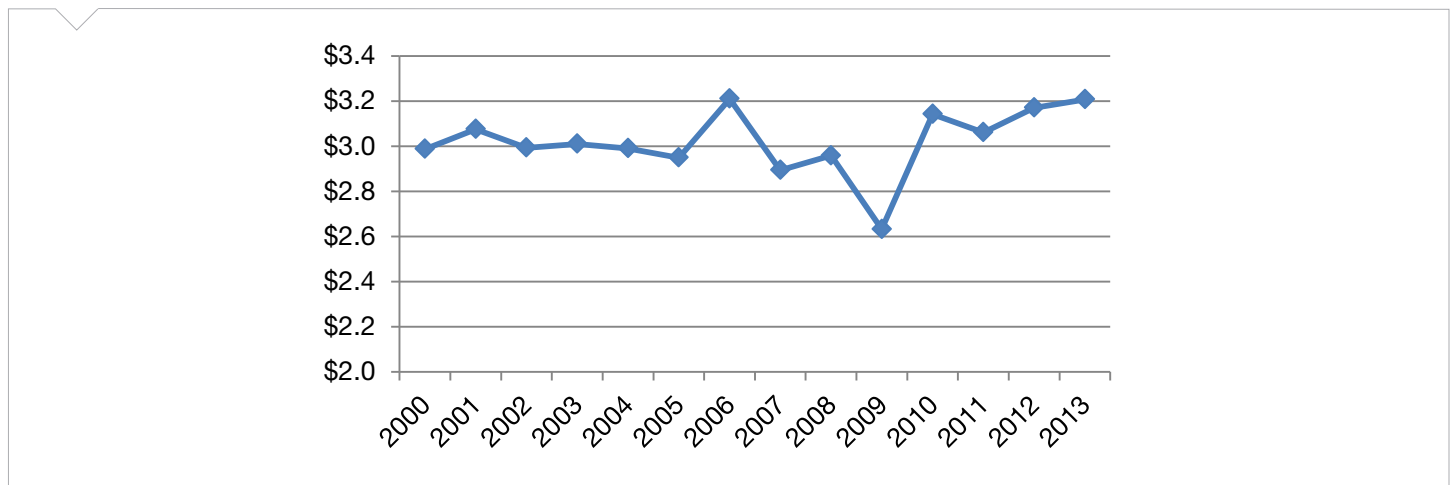
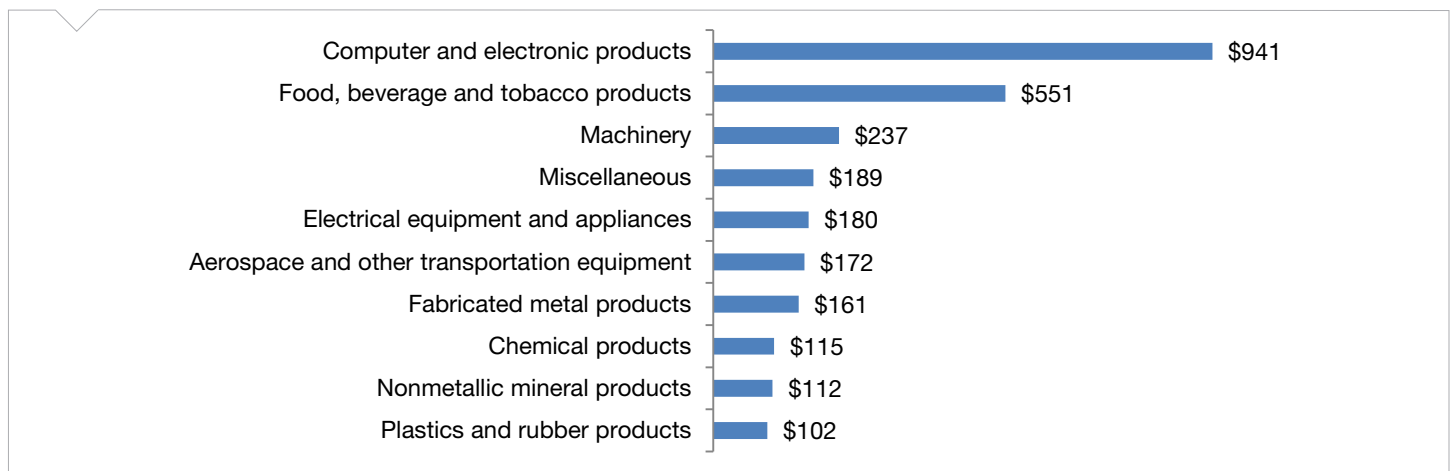


Figure 2: Top 10 Vermont Manufacturing Sectors, in Millions of Dollars, 2012



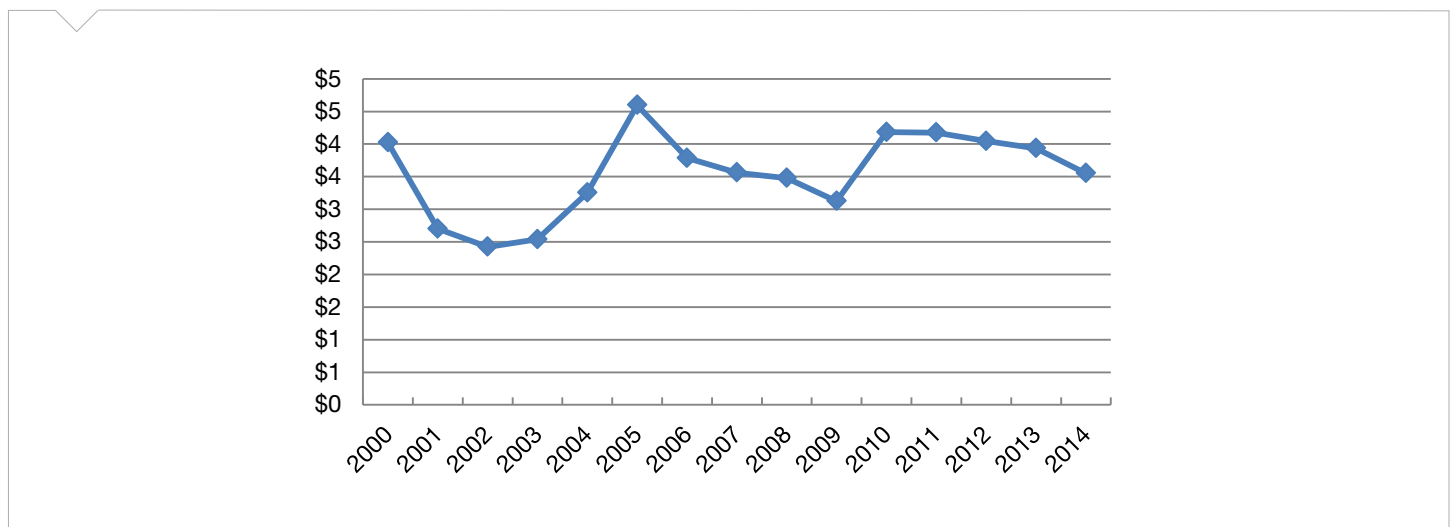
Vermont Export Facts

Manufacturers help to drive Vermont's economy, with \$3.55 billion in manufactured goods exports in 2014. That same year, \$2.01 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 20.70 percent of its employment stemmed from exports in 2011. Small businesses comprised 84.20 percent of all exporters in Vermont.

- In 2014, manufacturers in the United States sold \$55.0 billion more in manufactured goods to our FTA partners than we bought from them. The United States has a manufactured trade deficit of \$579.2 billion from countries where no FTAs existed.
- FTA countries: Australia, Bahrain, Canada, Chile, Columbia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
