# **Wisconsin** Manufacturing Facts

Manufacturers in Wisconsin account for 18.95 percent of the total output in the state, employing 16.1 percent of the workforce. Total output from manufacturing was \$57.93 billion in 2015. In addition, there were 472,400 manufacturing employees in Wisconsin in 2016, with an average annual compensation of \$68,878 in 2015.

Figure 1: Wisconsin Manufacturing Output, in Billions of Dollars, 2005–2015





Figure 2: Top 10 Wisconsin Manufacturing Sectors, in Millions of Dollars, 2014




## **Wisconsin** Export Facts

Manufacturers help to drive Wisconsin's economy, with \$19.76 billion in manufactured goods exports in 2016. That same year, \$10.84 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 20.20 percent of its employment stemmed from exports in 2011. Small businesses comprised 87.0 percent of all exporters in Wisconsin.
