Georgia Manufacturing Facts

Manufacturers in Georgia account for 11 percent of the total output in the state, employing 8.6 percent of the workforce. Total output from manufacturing was \$61.06 billion in 2017. In addition, there were 387.8 manufacturing employees in Georgia in 2017, with an average annual compensation of \$68,183 in 2016.

Figure 1: Georgia Manufacturing Output, in Billions of Dollars. 2005–2017




Figure 2: Top 10 Georgia Manufacturing Sectors, in Millions of Dollars, 2016




Figure 3: Top 25 Manufacturing Job Titles over the Past 12 Months in Georgia






Georgia Export Facts

Manufacturers help to drive Georgia's economy, with \$33.85 billion in manufactured goods exports in 2017. That same year, \$14.45 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 21.3 percent of its employment stemmed from exports in 2011. Small businesses comprised 89 percent of all exporters in Georgia.
