

# Rhode Island Manufacturing Facts

Manufacturers in Rhode Island account for 8.1 percent of the total output in the state, employing 8.3 percent of the workforce. Total output from manufacturing was \$4.84 billion in 2017. In addition, there were 41.1 manufacturing employees in Rhode Island in 2017, with an average annual compensation of \$70,260 in 2016.

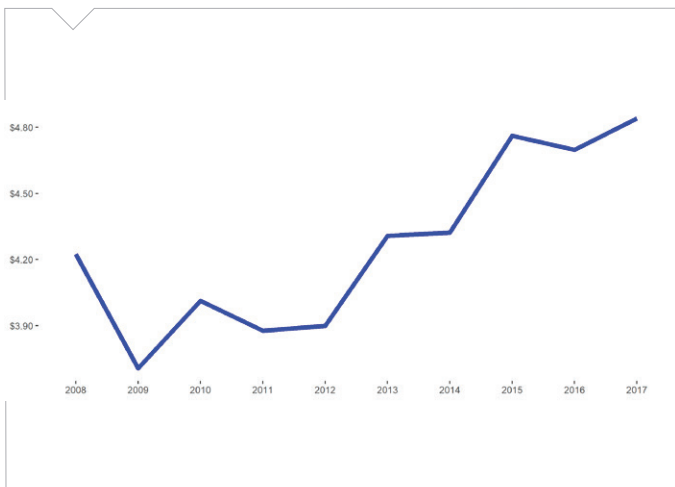

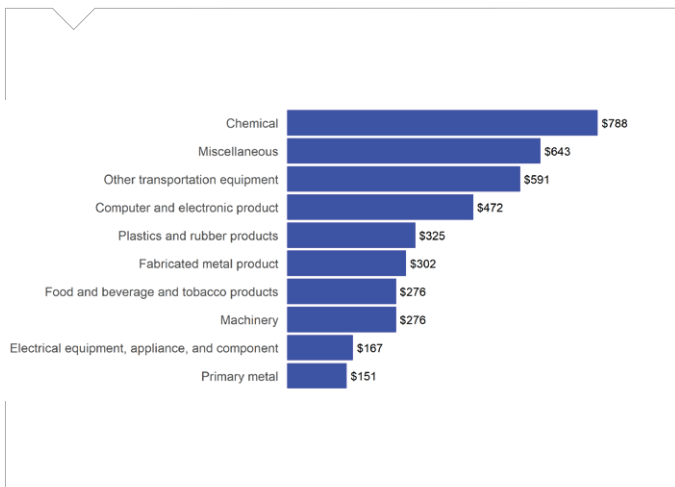

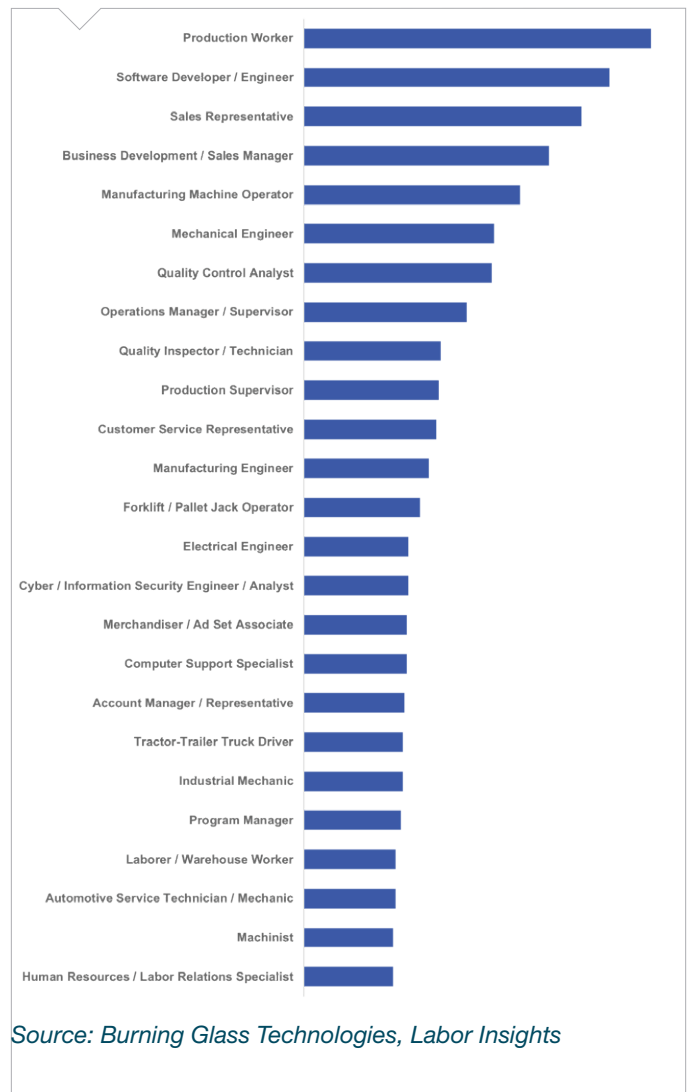
**Figure 1:** Rhode Island Manufacturing Output, in Billions of Dollars, 2005–2017

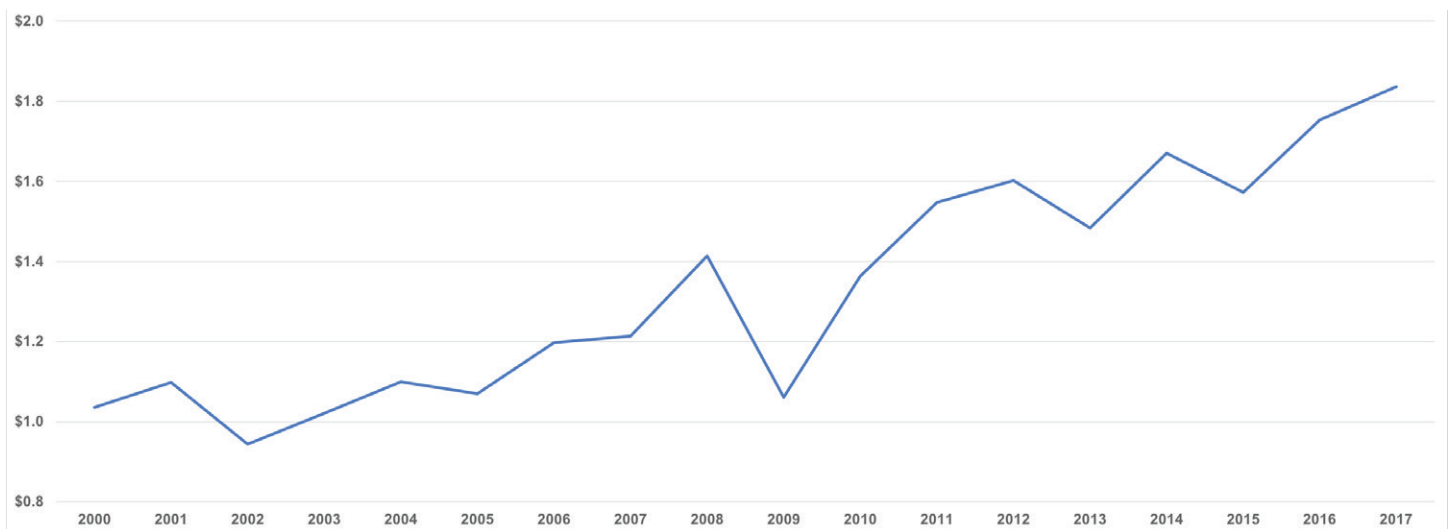
# Rhode Island Export Facts

Manufacturers help to drive Rhode Island's economy, with \$1.84 billion in manufactured goods exports in 2017. That same year, \$0.96 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 16.9 percent of its employment stemmed from exports in 2011. Small businesses comprised 88 percent of all exporters in Rhode Island.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$637.5 billion) of U.S. manufactured goods exports in 2017 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Colombia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
