

# United States Manufacturing Facts

Manufacturers account for 11.6 percent of the total output in the United States, employing 8.5 percent of the workforce. Total output from manufacturing was \$2,244.30 billion in 2017. In addition, there were 12,442.90 manufacturing employees in the U.S. in 2017, with an average annual compensation of \$84,832.

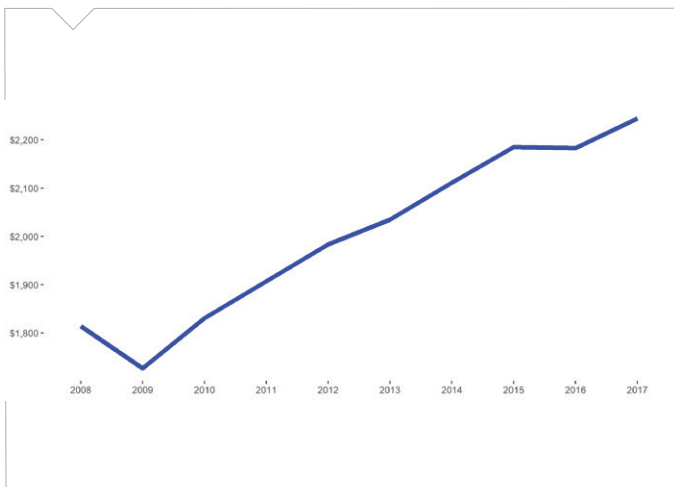

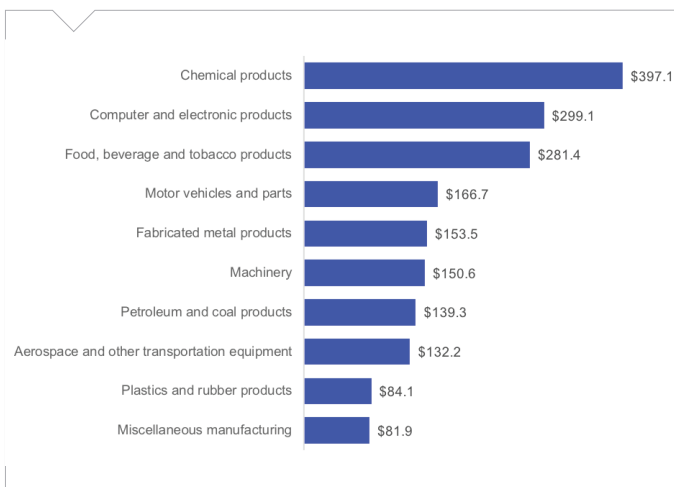

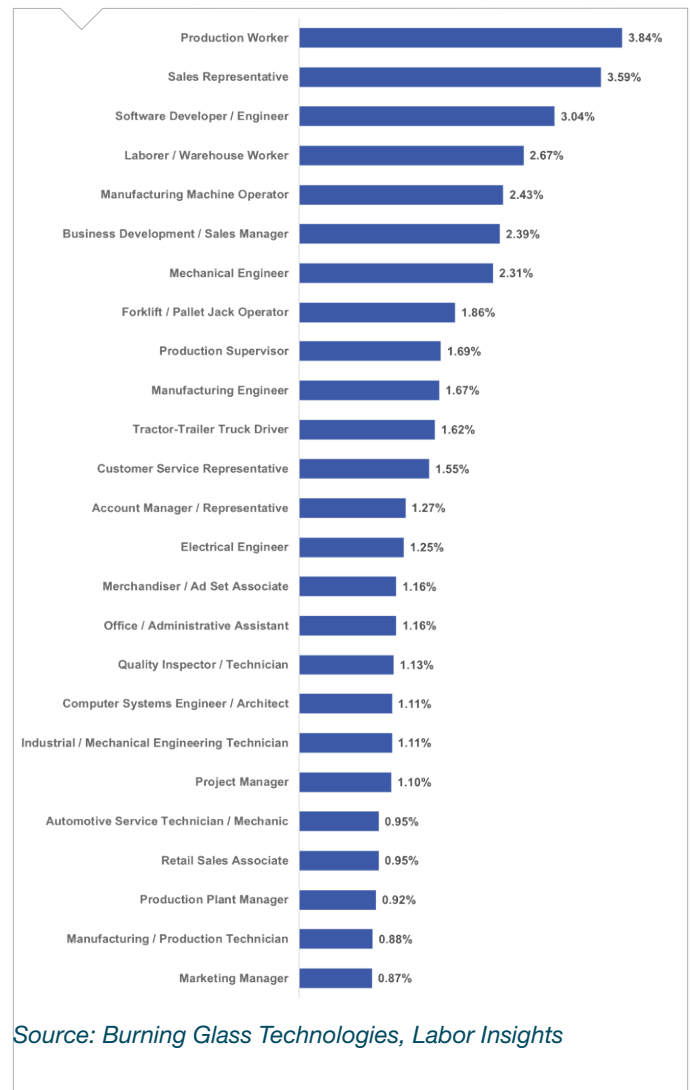
**Figure 1:** United States Manufacturing Output, in Billions of Dollars, 2005–2017

# United States Export Facts

Manufacturers help to drive the U.S. economy, with \$1,322.46 billion in manufactured goods exports in 2017. That same year, our free trade agreement (FTA) partnerships purchased \$636.08 billion in exports. Small businesses comprised 96.6 percent of all exporters in the United States.

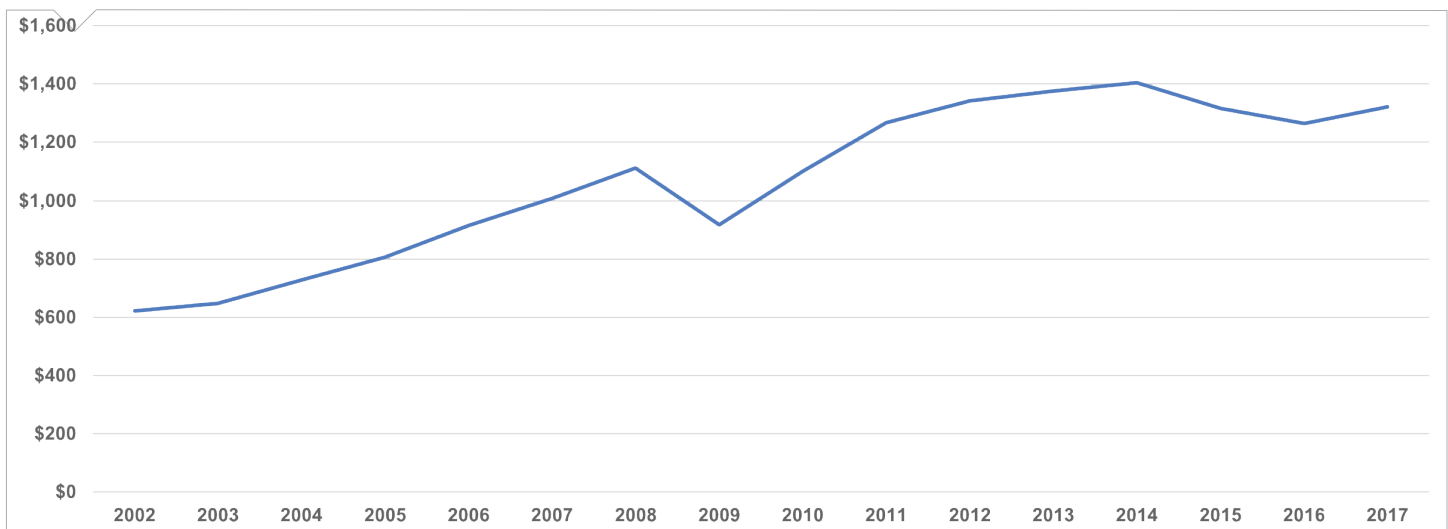

- The 20 U.S. FTA partners purchased nearly 48 percent (\$637.5 billion) of U.S. manufactured goods exports in 2017 – even though these countries represent only six percent of the world’s population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Colombia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
