

# Illinois Manufacturing Facts

Manufacturers in Illinois account for 12.6 percent of the total output in the state, employing 9.5 percent of the workforce. Total output from manufacturing was \$103.75 billion in 2017. In addition, there were 572,700 manufacturing employees in Illinois in 2017, with an average annual compensation of \$85,087 in 2016.

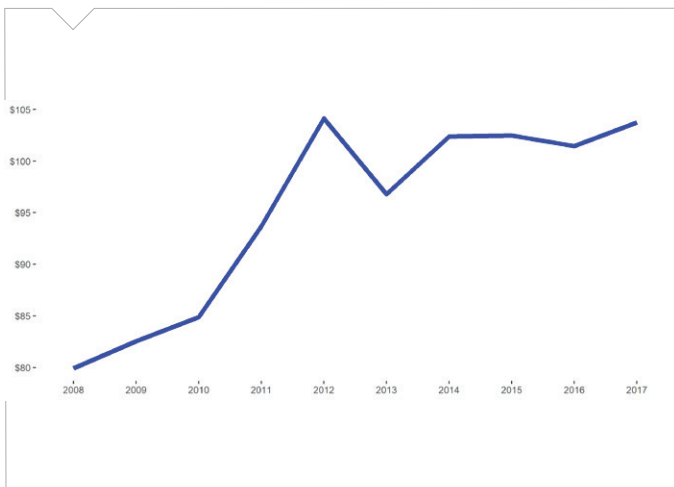

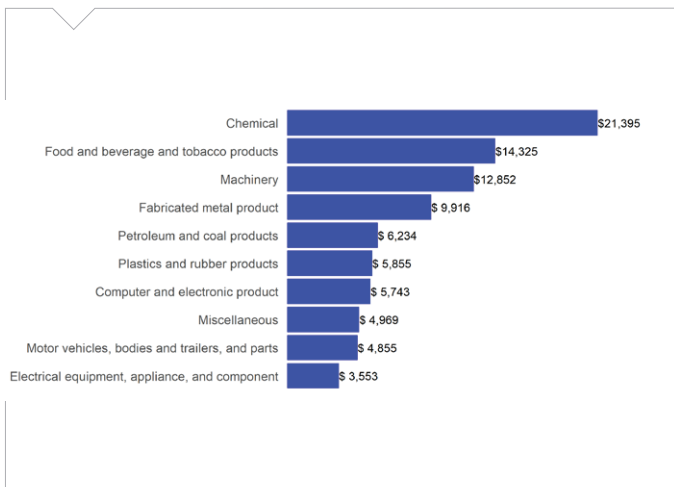

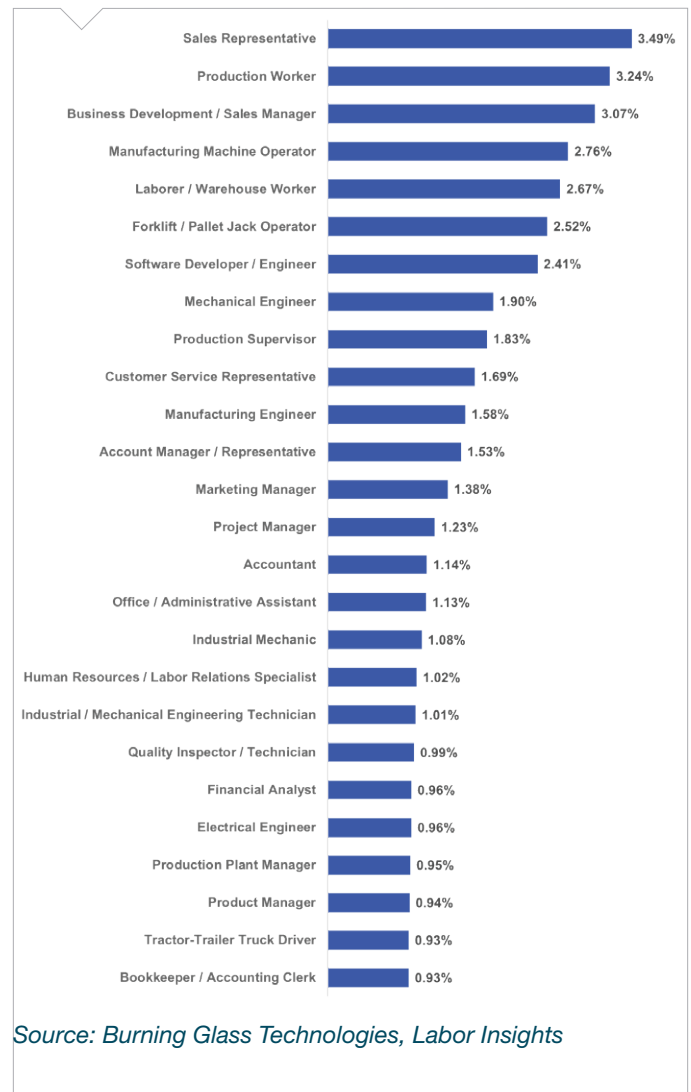
**Figure 1:** Illinois Manufacturing Output, in Billions of Dollars, 2005–2017

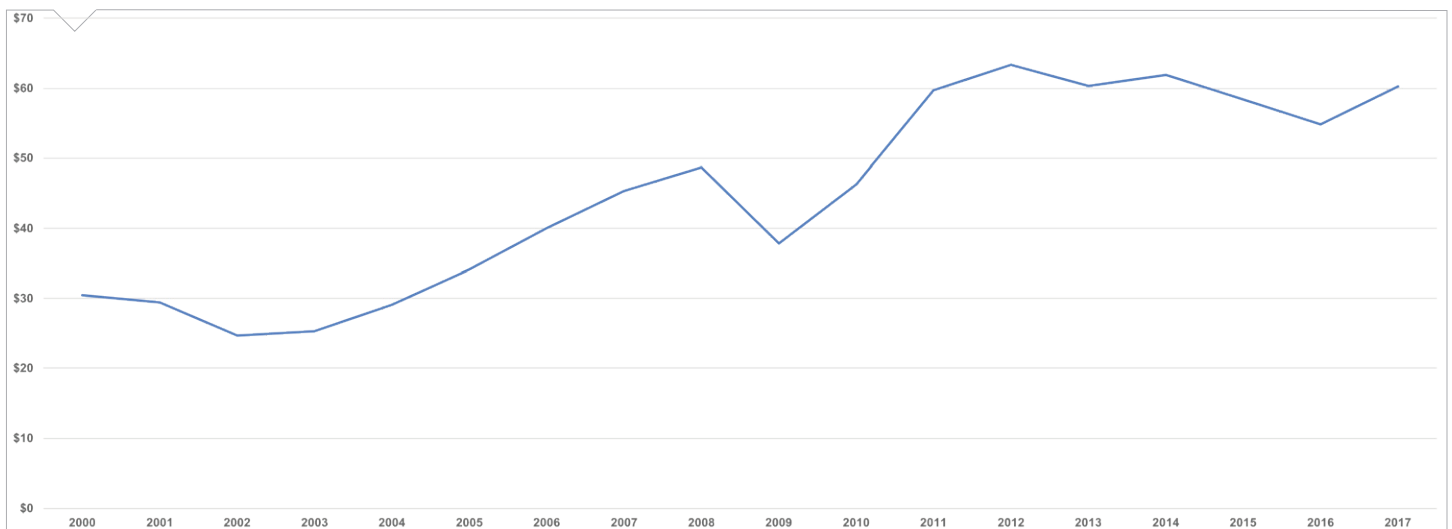
# Illinois Export Facts

Manufacturers help to drive Illinois's economy, with \$60.31 billion in manufactured goods exports in 2017. That same year, \$34.25 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 26.9 percent of its employment stemmed from exports in 2011. Small businesses comprised 90 percent of all exporters in Illinois.

## Additional Trade Facts

- The 20 U.S. FTA partners purchased nearly 48 percent (\$637.5 billion) of U.S. manufactured goods exports in 2017 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Colombia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
