

# Indiana Manufacturing Facts

Manufacturers in Indiana account for 28.6 percent of the total output in the state, employing 17 percent of the workforce. Total output from manufacturing was \$102.59 billion in 2017. In addition, there were 529,800 manufacturing employees in Indiana in 2017, with an average annual compensation of \$74,849 in 2016.

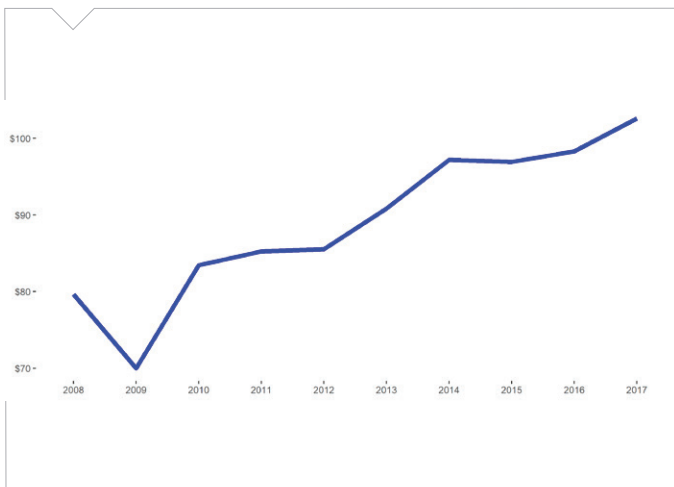

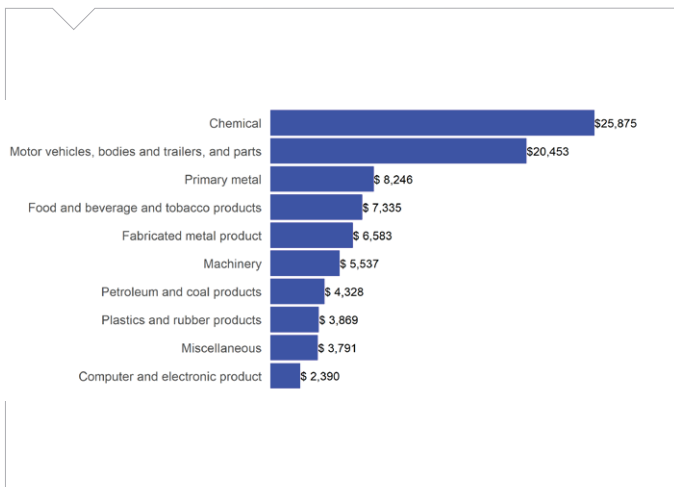

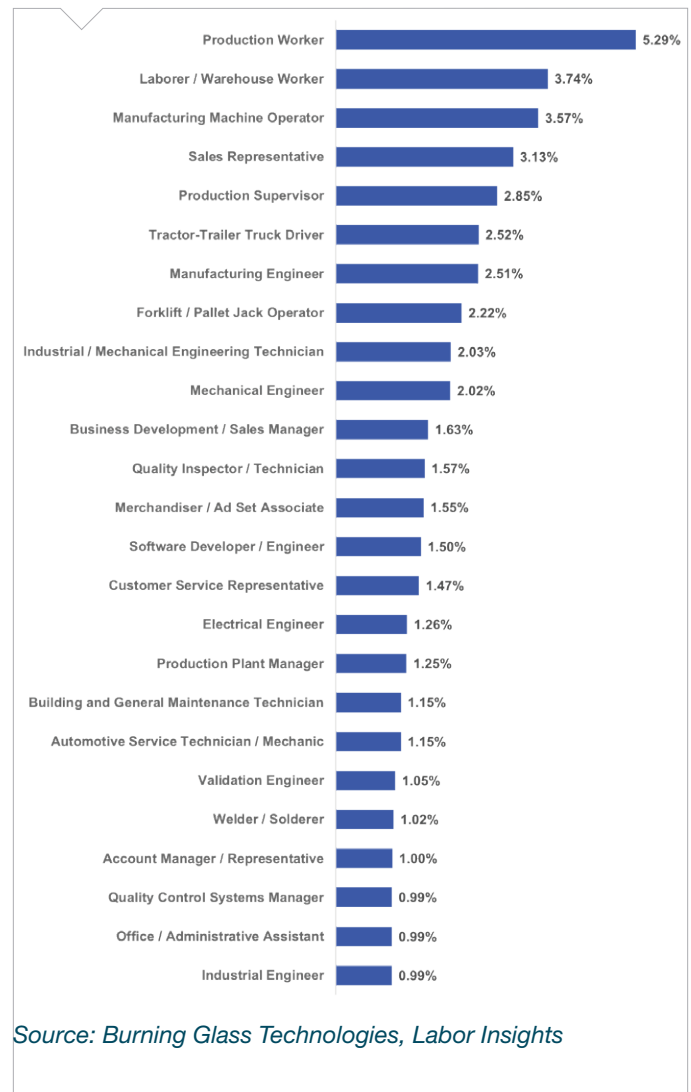
**Figure 1:** Indiana Manufacturing Output, in Billions of Dollars, 2005–2017

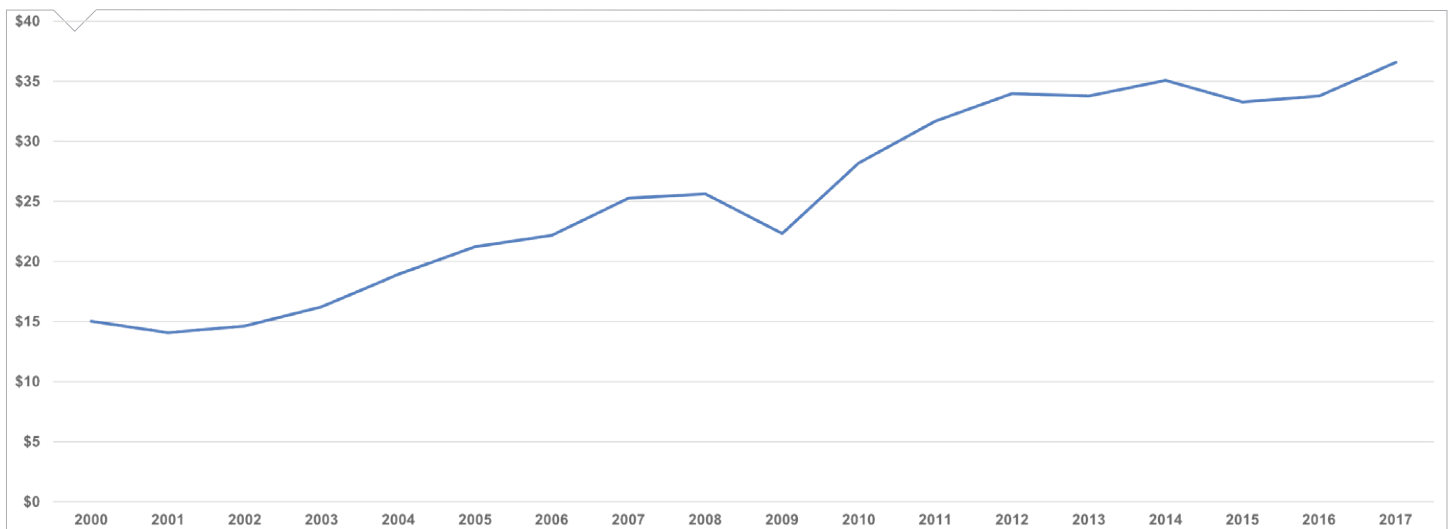
# Indiana Export Facts

Manufacturers help to drive Indiana's economy, with \$36.60 billion in manufactured goods exports in 2017. That same year, \$20.02 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 24.7 percent of its employment stemmed from exports in 2011. Small businesses comprised 85 percent of all exporters in Indiana.

## Additional Trade Facts

- The 20 U.S. FTA partners purchased nearly 48 percent (\$637.5 billion) of U.S. manufactured goods exports in 2017 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Colombia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
