

South Dakota Manufacturing Facts

Manufacturers in South Dakota account for 9.6 percent of the total output in the state, employing 9.5 percent of the workforce. Total output from manufacturing was \$4.79 billion in 2017. In addition, there were 41,600 manufacturing employees in South Dakota in 2017, with an average annual compensation of \$54,910 in 2016.

Figure 1: South Dakota Manufacturing Output, in Billions of Dollars, 2005–2017

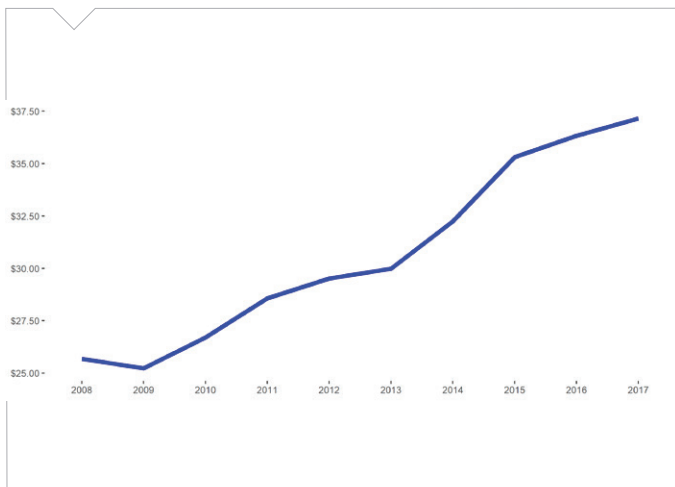


Figure 2: Top 10 South Dakota Manufacturing Sectors, in Millions of Dollars, 2016

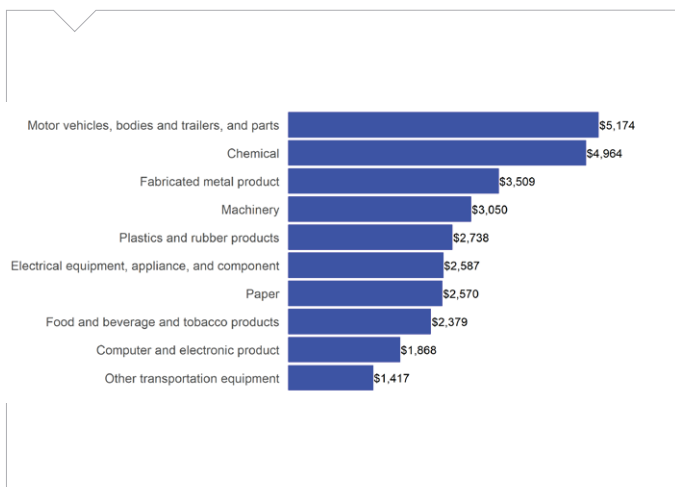
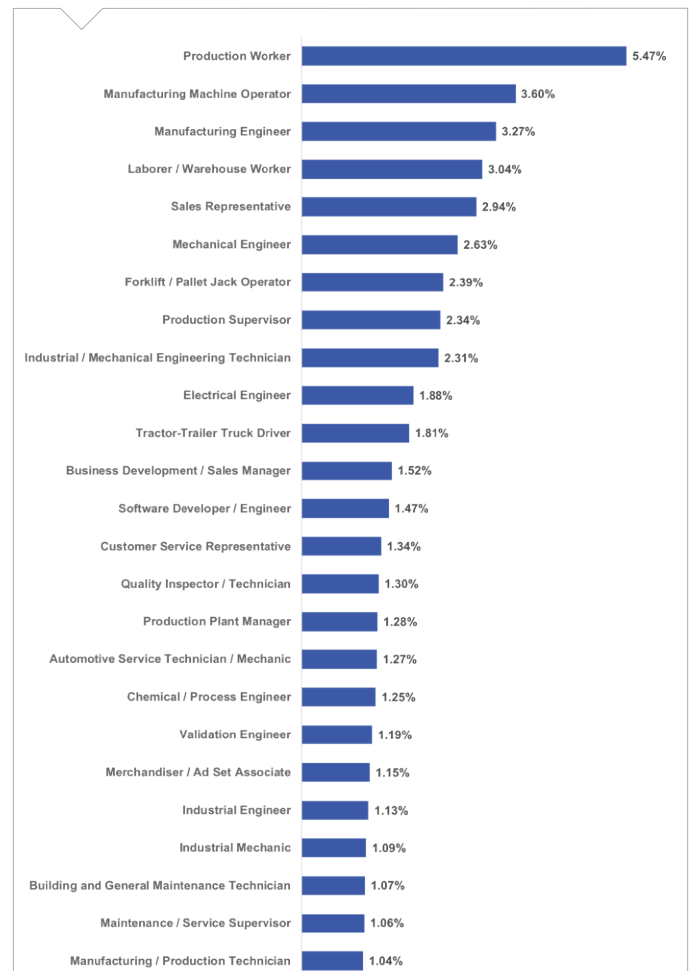


Figure 3: Top 25 Manufacturing Job Titles over the Past 12 Months in South Dakota

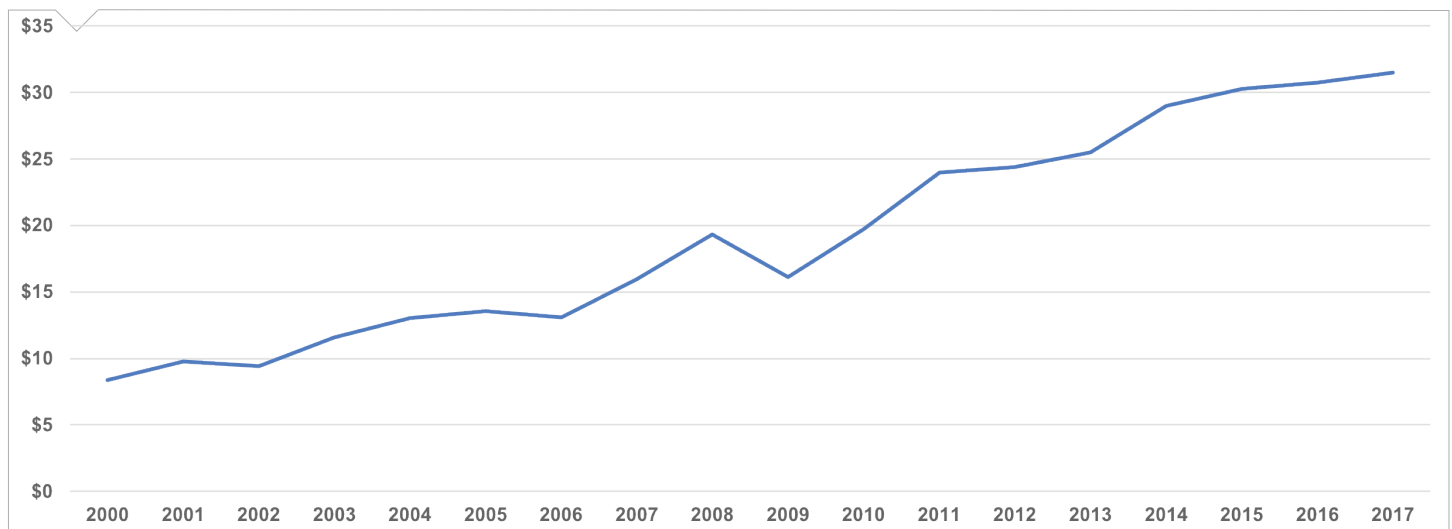
South Dakota Export Facts

Manufacturers help to drive South Dakota's economy, with \$1.26 billion in manufactured goods exports in 2017. That same year, \$0.91 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 17.1 percent of its employment stemmed from exports in 2011. Small businesses comprised 75 percent of all exporters in South Dakota.

- The 20 U.S. FTA partners purchased nearly 48 percent (\$637.5 billion) of U.S. manufactured goods exports in 2017 – even though these countries represent only six percent of the world's population and 10 percent of GDP.
- FTA countries: Australia, Bahrain, Canada, Chile, Colombia, Costa Rica, Dominican Republic, El Salvador, Guatemala, Honduras, Israel, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Singapore and South Korea.
